It is the plan of the "Friends of the Carousel" to request Council guarantee a loan of \$350,000 to purchase the carousel, with the funds to be repaid through the organization's fund raising efforts.

Arising from the discussion Alderman Young was granted leave by Council to introduce the following motion:





Alderman Young advised that he recently returned from the Western Canada Traffic Association Conference held in Whitehorse. The new president of the Association is Mr. Bill Bennett, a member of the Burnaby Traffic Safety Committee. Alderman Young stated that the conference provided valuable





experience for Committee members, particularly as Burnaby will be hosting the conference in October, 1990.

Alderman Sawicki

In accordance with Section 29, Burnaby Procedure Bylaw 1971, Bylaw No. 6023 Alderman Sawicki advised that she wished to bring back for reconsideration the motion of Council **DEFEATED** on 1989 September 25 regarding Rezoning Reference #61/89, an application to rezone a portion of 5665 Kingsway from C2 Community Commercial District to C2a Community Commercial District to facilitate development of a retail beer and wine store.

Although Council provided a grant of \$12,600.00 earlier in the year this was not sufficient to allow the program to continue operation.
