R E P O R T

Council at the regular Council Meeting held on 1988 October 03 received Item 11, Municipal Manager's Report No. 63 and adopted the following three recommendations:

1. THAT Council establish an Ad Hoc Advisory Committee composed of representatives of the residential neighbourhoods, local business people, a representative of Gilmore Community School and a Council member to assist staff in the preparation of a revised land use plan for the Hastings Street Community Plan Area.
2. THAT Council authorize in principle, the use of a Planning Consultant if deemed necessary by the Advisory Committee, to assist in the preparation of a revised plan on the understanding that a further report to Council regarding the costs and terms of reference would first be provided.
3. THAT staff be authorized to place advertisements in the newspaper inviting applications for positions on the Advisory Committee.
