MINUTES

- 1. Mr. Gordon Dowding, 4491 S.E. Marine Drive, Burnaby, B.C. appeared before Council to address the recycling report previously presented by the Environment and Waste Management Committee of Council.
 - Mr. Dowding discussed the recycling strategy put forward by the Committee in relation to the MacLaren Report, a regional recycling study commissioned by the G.V.R.D.

Alderman Rankin entered the Council Chamber at 7:05 p.m. and took his place at the Council table.

Mr. Dowding stressed the need for cooperative recycling strategies between G.V.R.D. member municipalities and cautioned against individual programs which may lead to inefficiencies in the recycling process.

The delegation concluded by requesting that Burnaby expand the area designated for recycling facilities to include materials from the G.V.R.D. and City of Vancouver in order to create a comprehensive facility to serve the Lower Mainland.

2. Mr. Michael Proniuk, #31 - 9000 Ash Grove Crescent, Burnaby, B.C. appeared before Council to request support for a moratorium on increased oil tanker traffic in Burrard Inlet until a comprehensive environmental assessment review process is conducted on the planned increase in tanker traffic.

The Burnaby Citizens for Environmental Protection are particularly concerned with the transportation of the product MTBE through Burrard Inlet.

The speaker also requested that Council take this issue up with other Burrard Inlet municipalities at the Greater Vancouver Regional District Board meeting on 1989 November 29 with the objective of having them endorse the call for an oil tanker moratorium and the Federal and Provincial environmental assessment review process.

His Worship, Mayor W.J. Copeland advised that the Chief Public Health Inspector is preparing a report in response to the delegation's presentation to be presented to Council at the regular meeting on 1989 November 27.

Council requested that information be provided in the report regarding the toxicity of MTBE.

3. Mr. Kim Moller, representing Canadian Records Management Ltd. advised Council that Canadian Records Management Ltd. wished to withdraw their request to appear as a delegation as they have now received information regarding Council's intent to deal with Preliminary Plan Approval Application No. 9501 regarding 6451 Telford Street.

The meeting agreed to bring forward Tabled Matters Item 1, Preliminary Plan Approval Application No. 9501 - Proposed mini storage use - 6451 Telford Avenue.

8. Preliminary Plan Approval Application No. 9501 Proposed Mini-Storage Use 6451 Telford Avenue

1. THAT this report be received for information purposes.



3. Mr. C.W. Bressler, 1989 November 07, Re: Street numbering - 4980 Kingsway

A staff notation appended to this item of correspondence advises that while the Municipality assigns new street names, the B.C. Assessment Authority is responsible for the issuance of new addresses to specific properties and buildings in Burnaby. Staff have advised Mr. Bressler of this and have asked the Assessment Authority to contact him directly with an explanation as to how the subject address was determined.

Arising from the discussion Council requested that staff contact the owners of Plaza 5000 requesting that they install signage on Kingsway advising that their building is located on the corner of Bennett and Kingsway and not Nelson and Kingsway.

4. The Canadian Red Cross Society, President, Burnaby Branch, 1989 November 07, Re: Thank you for support over past years

5. Svend Robinson, M.P. Burnaby-Kingsway 1989 October 31, Re: Environmental Partners Fund

A letter dated 1989 October 31 was received from Svend Robinson, M.P. advising Council that applications for funding under the Environmental Partners Fund will be dealt with in the regional offices of the Ministry of Environment.

6. Greater Vancouver Regional District, Secretary Treasurer, 1989 October 31, Re: Loan Authorization Bylaws for Regional Parks purposes

A letter dated 1989 October 31 was received from the Greater Vancouver Regional District requesting Council express approval for a five year capital expenditure program for regional parks planning. The program requires long term borrowing for major development and property acquisition.

A staff notation appended to this item of correspondence advises that the principal and interest costs of funds borrowed by the G.V.R.D. are distributed among member municipalities on the basis of assessed values. For the proposed \$5.75 million borrowing, the amount allocated to Burnaby is expected to be about \$75,000 annually for 20 years. This will cause the taxes levied by the G.V.R.D. to increase by about 6% over the next two to three years.

- 5) THAT following the six month period mentioned in Recommendation No. 4, staff again monitor the traffic volumes in the area to identify any changes and report back to the Traffic Safety Committee.
