His Worship, Mayor W.J. Copeland then recognized Ms. Coro Strandberg in the audience who was accompanied by three students from the U.B.C. Social Work Program. The guests were in attendance at the Council Meeting for the purpose of observation.

- 3. The delegation withdrew his request to appear before Council prior to the meeting.
- 4. Mr. Mike Mullan, 2nd Vice President of the Independent Canadian Transit Union, and also a resident of North Burnaby appeared before Council expressing support for the staff report recommending that the No. 120 Bus Route not be changed.

In response to a request from Council, Mr. Mullan advised of a number of problems that would be associated with the re-routing of the No. 120 Bus.

1. Mr. Nikolas Cuff, 6233 - 9th Avenue, Burnaby, B.C. appeared before Council expressing opposition to any proposal for the development of a race track in the Big Bend area. Mr. Cuff reminded Council of the Big Bend area's unique character in terms of its agricultural capabilities and that the agricultural lands, for the most part, are family owned and labour intensive. The markets at which the crops are sold contribute to the agricultural growth of the Lower Mainland and the allotment gardens provide residents with an opportunity to farm land in an urban environment.



Alderman Rankin

Alderman Rankin requested staff to comment on whether a review has been conducted in the Municipality of all major structures in terms of stability should a seismic event take place.

The Municipal Manager advised that although a comprehensive plan is not in place for Burnaby, the greatest concern should an earthquake take place would be on the underground utilities. Mr. Olson suggested that a comprehensive plan would be a matter that should be more closely examined in the future.

In addition to the Municipal Manager's comments, Mr. Craig Sinclair, Acting Director Engineering advised that in 1987 a bridge inventory study was conducted which included the 20 municipally-owned bridges. The study resulted in recommendations for various maintenance measures and also included a seismic evaluation of the bridges. Mr. Sinclair advised that seismic retrofitting was recommended for several bridges and to date three have been completed and it is anticipated that the other two will be completed during 1990.

Alderman Young

Alderman Young then discussed the matter of the Provincial Government's error in neglecting to make application to the Federal Government for emergency planning funding. As a result, communities in B.C. will receive less than \$5,000 where communities in Ontario will receive in excess of \$1 million.

Arising from the discussion Alderman Young was granted leave by Council to introduce the following motion:
