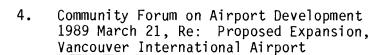

Alderman Drummond

Alderman Drummond introduced and read the following Notice of Motion regarding the taxation of oil refinery tanks.

MOVED BY ALDERMAN DRUMMOND: SECONDED BY ALDERMAN NIKOLAI:

"THAT

WHEREAS in the past all oil refinery storage tanks could be taxed for general municipal purposes; and

WHEREAS in 1987, in a test case involving 35 tanks owned by Chevron Canada Limited, the Court's decision was to classify blending tanks as machinery rather than improvements; machinery cannot be taxed for general municipal purposes or provincial purposes; and

WHEREAS following this Court ruling, the Provincial Government in 1987 enacted legislation which intended to make all refinery storage tanks, including blending tanks, taxable except the 35 tanks included in the test case; and

WHEREAS both Chevron and Shell appealed their 1988 Assessments on the remainder of their tanks and their appeal is related to an interpretation of the new provincial legislation of 1987; and

WHEREAS if Chevron and Shell win their appeal with the Assessment Authority it will cost the Municiplity of Burnaby approximately \$1 million in lost municipal taxes from the heavy industry category of the petroleum industry between the years 1987 - 1989;

THEREFORE BE IT RESOLVED that municipal staff bring forward a recommendation related to this potential loss in tax revenue which in no way penalizes residential, commercial or the light industrial taxpayers in the Municipality of Burnaby."

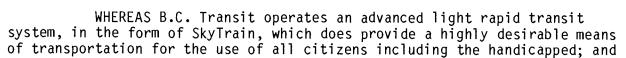

Alderman Nikolai

Alderman Nikolai introduced a Notice of Motion regarding wheelchair accessibility to Metrotown to be brought before Council at the regular Council Meeting on 1989 April 10.

Alderman Nikolai read the text of the Notice of Motion as follows:

WHEREAS the Premier's Advisory Council for Persons with Disabilities promotes the achievement of equitable access for persons with disabilities such as those in wheelchairs to destinations such as the Metrotown core development, a strong regional shopping, business and entertainment focus; and



WHEREAS handicapped persons, especially in wheelchairs, utilizing SkyTrain must at present utilize an elevator which requires them to cross Central Boulevard at grade, a busy, wide street; and

WHEREAS the grade-separated pedestrian passerelle over Central Boulevard linking the Metrotown Skytrain station to the Metrotown core is now complete and is designed to provide for handicapped ramps when required:

THEREFORE BE IT RESOLVED THAT B.C. Transit immediately investigate and resolve to provide wheelchair accessibility from the Metrotown SkyTrain station to the Metrotown core development via the grade-separated passerelle over Central Boulevard.

His Worship, Mayor W.J. Copeland

His Worship, Mayor W.J. Copeland read a letter addressed to Director Recreation and Cultural Services, Mr. Dennis Gaunt from "Go B.C." advising that the Corporation of Burnaby has been awarded a grant in the amount of \$216,550 for the development of 10 neighbourhood parks.

Council expressed their appreciation to The Honourable Elwood Veitch, MLA Burnaby/Willingdon for his support of the Municipality's grant application.

ENQUIRIES

Alderman Drumond

Alderman Drummond enquired as to whether or not any response has been received to the Municipality's application for cost sharing from the Ministry of Highways.

Deputy Director Engineering, Mr. W.C. Sinclair advised that the Ministry of Highways has acknowledged receipt of the Municipality's application but has not yet provided a response.

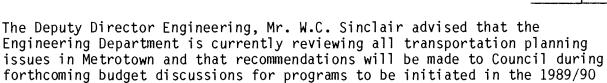
Alderman Drummond made a further request of staff regarding a report to be presented to Council similar to that prepared by the District of West Vancouver, in relation to revenue sharing grants, which includes analysis of a reduction in revenue sharing grants. Alderman Drummond advised that the total revenue sharing grant is \$280 million and the portion related to unconditional grants is \$110 million, which is approximately 39% of the total of revenue sharing. In previous years, the unconditional grants amounted to 80% of revenue sharing; in the Notice of Motion previously submitted to the Provincial Government, Burnaby Council requested unconditional grants be established at 60% of revenue sharing, and staff are requested to address these disparities in the forthcoming report.

Alderman Corrigan

Alderman Corrigan enquired into the next stage of planning for Metrotown and what the next process will entail.

Deputy Director Planning and Building Inspection, Mr. D.G. Stenson advised that in keeping with the Council established policy and plan for Metrotown, staff are working toward urban design and character enhancement of the Metrotown area as the next project. Reports will be prepared to be submitted to Council regarding the introduction of walkways, more store fronts and a more pedestrian oriented environment with more open space concepts throughout the development.

Alderman Corrigan also enquired as to the status of traffic back-ups at Willingdon and Kingsway and whether or not planning is taking place with regard to resolving transportation issues in Metrotown.
