2. Mr. Charnjit S. Bal, 6521 Curtis Street, Burnaby, B.C. appeared before Council to present a petition from residents of Curtis and Parker Streets complaining of traffic volumes and expressing support for commuter rail and contruction of the Hastings/Gaglardi Connector.

The speaker also requested Council give consideration to upgrading Kensington Avenue in front of Burnaby North Secondary School and the installation of street lighting in the 6500 block Curtis Street.

3. Mr. Harvey Elder, 8251 - 14th Avenue, Burnaby, B.C. appeared before Council on behalf of the East Burnaby Ratepayers Association expressing dissatisfaction with Parking Bylaw regulations which stipulate time limits for non-resident on-street parking and parking distance between driveways.  Proposed Replacement of the Relief Tank/Burnaby Terminal/Trans Mountain Pipeline Preliminary Plan Approval No. 9316

The Municipal Manager submitted a report from the Director Planning and Building Inspection advising Council that Trans Mountain Pipeline has made a Preliminary Plan Approval Application to replace an existing "Relief Tank" at the Burnaby Terminal. The main function of the tank is to provide a storage reservoir into which the pipeline can route oil on an emergency basis if the pressure in the line reaches unacceptable limits. The existing tank has become inadequate due to the increase in pipeline capacity.


