1. Mr. Paul Gill, representing Bonny's Taxi Ltd., appeared before Council to address the report of the Director Planning and Building Inspection regarding the provision of taxi stands in the development and/or redevelopment of commercial, recreational and public facilities in Burnaby.

Mr. Gill presented photocopied pictures of various taxi stands in the community. Some of the stands are marked "Taxi Only" and some are not. The speaker drew Council's attention to the proximity of the stands to retail establishments. Bonny's Taxi have divided Burnaby into nine zones so that service may be provided to all areas of the community. In addition to the nine zones, there are ten on-street and ten shopping mall taxi stands.

The speaker also requested marked stands at SkyTrain stations which would be separate from the Handy Dart locations.

In conclusion, Bonny's Taxi requested that the staff report remain tabled and they be permitted to work with staff to establish additional marked taxi stands at various locations in the community and requested the Municipality's assistance in obtaining two car stands at Burnaby shopping malls.

2. Mr. Fred Hodges, 2638 Cactus Court, North Vancouver, B.C. representing Discovery Parks Incorporated appeared before Council to address Rezoning Reference #52/89 pertaining to the Discovery Parks development at Simon Fraser University.

Mr. Hodges advised that Discovery Parks leased 75 acres from Simon Fraser University for development at a prescribed rate. Mr. Hodges presented a drawing which shows the 75 acres, the proposed phases of development, the initial construction and the parking presently located on the B.C. Hydro right-of-way. There has not been any development at the site since the completion of the first construction in 1982. This is due to the economic downturn in 1981 to 1985 and the ongoing onerous financial conditions associated with construction of underground parking as a requirement of the community plan.

In 1989 a rezoning application was made to develop a 30,000 sq. ft. facility to accommodate technology-based companies. In conjunction with the application Discovery Parks proposes to provide all necessary parking for employees on the B.C. Hydro power line right-of-way, and a small amount of parking for handicapped and service vehicles on the service road at the rear of the building. The number of parking spaces proposed exceeds the amount of parking required by the zoning bylaw. The cost of providing underground parking is estimated at \$400,000 which results in a 20% increase in construction costs.

The speaker then provided comments specifically addressing points made in the Planning Department Rezoning Report.

In conclusion Mr. Hodges advised that if underground parking is retained as a requirement of the development it may result in cancellation of the expansion, termination of future development and the lands reverting back to Simon Fraser University. The speaker requested that Council approve the request for surface parking and forward the proposal to a Public Hearing.
