AND WHEREAS the Government of the Province of British Columbia, in its commitment to offset the annual operating deficiencies and to finance the high capital cost of the SkyTrain system extensions, is placing an ever increasing burden upon all residents of the Greater Vancouver area; THEREFORE BE IT RESOLVED that the Government of the Province of British Columbia be requested to commit further that any outstanding financial debt, capital cost and operating expense incurred by SkyTrain be offset, or supplemented, with the proceeds from B.C. lotteries."
