## PRESENTATION

 Greeting from Sister City El Zapotal, El Salvador Presenter - Lisandro Perez

Alderman Sawicki welcomed representatives from El Zapotal and introduced Mr. Lisandro Perez, Columbe Lariviere, interpreter and Fran Diamond of the SalvAide organization.

Alderman Sawicki provided some background information on Mr. Perez who is Mayor of San Jose Los Flores, a neighbouring community to El Zapotal.

Mr. Perez brought greetings from El Zapotal and provided information on current events in that community. Before coming to Canada Mr. Perez met with the community Council of El Zapotal and advised that although the community has suffered during the war the citizens remain hopeful for the future.

Al'derman Sawicki expressed Council's condolences on the anniversary of the assassination of six Jesuit Priests and their two housekeepers in El Salvador.

Mayor W.J. Copeland then presented Mr. Perez with the framed documents signifying the twinning relationship between El Zapotal and Burnaby.

 British Columbia Institute of Technology Re: Presentation of pilot of the BCIT/Burnaby joint project on "Approach to Environmental problems" using artificial intelligence <u>Presenters</u> - Jeff Skosnik and Drug Svetic

Dr. Jeff Skosnik and Mr. Drug Svetic appeared before Council to present a demonstration of the artificial intelligence project for providing environmentally friendly alternatives for common household pesticides.

Dr. Skosnik went through the computer system demonstrating its use through the resolution of a problem associated with diseased carrots.

#### NEW BUSINESS

#### Alderman Nikolai:

Alderman Nikolai requested that Council agendas be circulated to the North Burnaby students attending the Council meeting.

Alderman Nikolai also requested staff investigate abandoned homes opposite the Burnaby Post Office to determine whether or not the mortgage holder could be convinced to demolish these buildings.

The Deputy Director Planning and Building Inspection, Mr. D.G. Stenson, advised that demolishing of the buildings is a prerequisite to the rezoning application, but that under normal circumstances buildings are not to be demolished prior to third reading of the rezoning bylaw. However, in the event that buildings are vandalized and cause a safety concern the Fire Prevention Officer may order their demolition. Staff will request the Fire Department do an assessment of the properties in question to determine whether or not they are to be demolished.

#### Alderman Young:

Alderman Young expressed concern with regard to the no parking signs on the newly constructed Wilson Street. Alderman Young expressed a view that day parking should be provided on this street.

MOVED BY ALDERMAN YOUNG: SECONDED BY ALDERMAN BEGIN:

"THAT the no parking signs on Wilson Street be **REFERRED** to the Traffic and Transportation Committee for review."
