The increase requested is for \$1.15 per kilometre which is 5 cents higher than the already approved \$1.10 per kilometre. The purpose of the increase is to help offset the additional cost of a dispatcher recently hired by the company.

The speaker concluded by requesting Council approve the request for the increase of \$1.15 per kilometre.

2. Housing and Civic Development Committee

The Housing and Civic Development Committee submitted a report requesting Council approval for the preliminary design and estimate for construction of the Confederation Park Pool Project. The Committee is also requesting Council authority for the architect to proceed to the next step in the process and that staff be directed to bring down the appropriate bylaw from Capital Reserves to fund the pool construction. It is anticipated that the architects will be able to prepare the final working drawings and tender documents in order that the pool project can be ready for tendering in early 1991. The Housing and Civic Development Committee recommended:

- 1) THAT the preliminary design of the pool and estimate in the amount of \$7,980,100 as outlined in this report be approved.
- 2) THAT the architects be authorized to proceed to preparation of final working drawings and tender documents.
- 3) THAT Council be asked to bring down the appropriate bylaw from Capital Reserves in the amount of \$7,980,100 to fund the pool construction.

The improvements arise from the Urban Design Study carried out by Hughes Baldwin Architects and were identified prior to the design of the Confederation Pool. The overall architectural plan demonstrates the benefits of proceeding with the proposed improvements which include landscaping, improvements to existing parking areas and pedestrian linkages to adjacent park facilities at the same time as the pool project is constructed.

The Municipal Manager recommended:

- 1) THAT the improvements to Confederation park outlined in the report be approved at an estimated cost of \$273,800.
- 2) THAT the Solicitor be instructed to bring down a bylaw to appropriate \$273,800 from Capital Reserves to carry out the improvements.

> Parks and Recreation staff have reviewed the potential for recreational use of both subject sites and concluded that no requirement exists. Other Municipal departments have been surveyed and it has been concluded that there does not appear to be any foreseeable requirement for institutional or community services development of the subject sites.

The Municipal Manager recommended:

- THAT Community Plan Seven be adjusted to designate the municipally-owned site at 7285 Kitchener Street for "Non-profit Residential Comprehensive Development based on RM1 guidelines at a density of 10 to 12 units per acre or alternatively of 20 to 25 units per acre if full underground parking is provided".
- 2) THAT Community Plan Seven be adjusted to designate the municipally-owned site at 7409 Halifax Street for "Residential Comprehensive Development - RM4 or RM3 density to be determined".
- 3) THAT staff be authorized to prepare reports regarding initiation of a "Request for Proposals" for development of the proposed non-profit housing site (7285 Kitchener Street) and to initiate its rezoning to establish community plan guidelines for development based on the above-noted designation.
