1. Ms. Connie Huber, #2 - 3963 Bond Street appeared before Council with concerns regarding rent increase and negligent maintenance practices at Farrington Court Apartments on Bond Street. The speaker advised the building is 30 years old and even though the landlords are not held accountable for repairs that are necessary, the rents continually increase on a yearly basis. The speaker also questioned the practice of the Arbitration Board where each individual tenant must lodge their own complaint for a fee of \$30.
2. Ms. Bonnie D. White, #6 - 3963 Bond Street appeared before the members of Council supporting the comments of the previous speaker and providing Council with an extensive list of repairs that are required to bring the Farrington Court apartment building to an acceptable living standard for the tenants. (The speaker was concerned that tenants are losing their damage deposits when the move to cover the cost of repairs that have existed for some time.) In conclusion, Ms. White stressed the fact that Farrington Court Apartments is considered a family oriented facility and yet the play facilities for the children have been removed and they are not permitted to play ball on the apartment grounds.

Arising from Council's consideration of the comments of the two delegations the following motions were introduced:

Mr. Legge advised that the Association has come to an impasse with Burnaby staff regarding the conditions of the lease signed between the District of Burnaby and the Bicycling Association of B.C. The speaker provided Council with a list of the funds raised to date and advised that letters of commitment have been received from all participants. The speaker was of the opinion that Burnaby staff's interpretation of "cash flow" is not stated or implied in the lease agreement and is considered to be less than fair. The Bicycling Association of B.C. is approximately \$100,000 short of the goal of \$2.3 million for finishing the entire sports centre.

In conclusion, Mr. Legge was of the opinion that the Bicycling Association of B.C. have met the spirit of the lease and therefore request Council indicate their support in this regard.
