Mr. Doug Neden, Greater Vancouver Water District appeared before Council 1. to provide an outline of the G.V.W.D.'s Drinking Water Quality Improvement Plan.

Mr. Neden provided a slide presentation outlining the necessity for the program including an upgrading of water quality standards, the advent of more sensitive laboratory techniques to detect bacteria and increased consumer expectations.



Aldermen Drummond and Rankin entered the Council Chamber at 7:07 p.m. and took their places at the Council table.

The speaker outlined the problems associated with poor water quality including disease, coliform counts, turbidity and corrosion.

The benefits of the improvement plan include reduced turbidity, improved bacterial protection and reduced corrosion and staining.

Alderman Sawicki retired from the Council Chamber at 7:51 p.m.

Alderman Rankin returned to the Council Chamber at 7:52 p.m. and took his place at the Council table.

2. Mr. Mark Livingstone, 3805 Bidwell Bay Road, Belcarra appeared before Council to present an alternative means of providing water-borne fire protection to Burnaby.

The speaker outlined an analysis of the risk associated with a petroleum industry fire on the waterfront, an analysis of the true cost of providing the equipment and manpower for fire suppression services, and the operational considerations involved in operating a fast attack fire protection vessel.

The speaker concluded by requesting Council's endorsement of the proposal and support in bringing it before the GVRD, the Vancouver Port Corporation, the surrounding municipalities and petroleum industries.



Movement and storage of hazardous goods in the Burrard Inlet Basin

The Vancouver Sun reported on 1990 October 16 that the Brander-Smith Report is to be presented to the Minister during the week of 1990 October 22. The report will quite likely have a bearing on whether or not the technical working group should be reconvened. In any event, Council will continue to be kept informed by staff as future events occur in regard to this matter.

1. Proposed Port Fire Protection Service

The Acting Municipal Manager submitted a report outlining a proposal for an integrated five municipality fire protection system for the Vancouver harbour. The proposal includes four unmanned "fast response" fireboats each with a pumping capacity of 3,000 gpm and a marine firefighting platform with a pumping capacity of 10,000 gpm. The system would provide for a total water born pumping capacity of 22,000 gpm for a major fire. Burnaby's share of the capital costs and initial training costs is estimated to be \$300,000 with the annual operating cost estimated to be \$23,000.

The costs are based upon a combination of population and waterfront industrial assessment, reflecting an ability to pay and the amount of fire protection required.

The Acting Municipal Manager recommended:

- 1) THAT Council approve in principle the proposed Port Fire Protection Service outlined in this report subject to approval by the Port of Vancouver and the other participating municipalities and satisfactory legal agreements.
- 2) THAT Council authorize staff to draft, and prepare for Council approval, agreements required to give effect to the intent of the report.
- 3) THAT the Port of Vancouver and participating municipalities be advised of the results of Council deliberations.

1. Escort Service for Tanker Traffic in Burrard Inlet

The Municipal Manager submitted a report from the Acting Chief Public Health Inspector prepared in response to Council's request for information on a business operating out of North Vancouver which provides escort service for tanker traffic in the Burrard Inlet. In addition to the escort service the company also provides immediate site supervision, spill containment and recovery services as well as the ability to fight fires. These additional services supplement the present spill response mechanisms in the Burrard Inlet and ensure minimal damage to the environment in the event of an oil or chemical tanker spill. As a result, it is the opinion of staff that the Vancouver Port Corporation should require all oil and chemical tankers using Burrard Inlet to provide an escort to the tankers which includes provisions for spill containment and recovery services.

The Municipal Manager recommended:

- 1) THAT a copy of this report be forwarded to:
 - a) Captain Norman C. Stark, Acting Port Manager and Chief Operating Officer, Vancouver Port Corporation, Suite 1900 - 200 Granville Street, Vancouver, B.C. V6C 2P9, and

 - c) City of Vancouver and all municipalities bounded by the Burrard Inlet.



 Future of the Federal Cooperative Housing Program

3. Royal Oak Avenue between the Moscrop/Gilpin Connector and Sanders Street

The Municipal Manager submitted a report from the Director Engineering requesting Council authority to retain a consultant for the design and construction supervision of Royal Oak Avenue and to initiate a bylaw to provide the necessary funding. The design concept presented reflects changes made as a result of public input received at an open house held on 1989 January 18. The concept for the Royal Oak Realignment is that of a four-lane secondary arterial road which is not part of the truck route system. The current schedule for this project as outlined in the 1990 to 1994 Capital Budget calls for design to commence in 1990 with construction to follow in 1991/92.

The Municipal Manager recommended:

- 1) THAT a bylaw to appropriate \$650,000 from the Capital Works Machinery and Equipment Reserve Fund be brought down for the engineering fees required for the design and construction supervision of the Royal Oak Avenue Improvements between the Moscrop/Gilpin Connector and Sanders Street.
- 2) THAT upon the adoption of the appropriation bylaw N.D. Lea Consultants Ltd. be retained to provide engineering consulting services for the Royal Oak Avenue major road project as more completely detailed in the report.

4. Tender for the Parks Facility Automation Project

The Municipal Manager submitted a report from the Director Finance advising Council of the results of tenders received for the Parks Facility Automation Project.



The work includes the expansion of reception offices and customer services counters, increasing the security of reception areas, the addition of storage space and, in two locations, the addition of new staff offices required due to the displacement of existing work space by the proposed customer service upgrading. These modifications will take place at Willingdon Heights Community Centre, Burnaby Arts Centre, Edmonds Community Centre for the Retired, Eastburn Community Centre, Cameron Recreation Centre and Burnaby Mountain Golf Course.

The Municipal Manager recommended:

THAT a contract be awarded to the lowest bidder, Boyle Madden General Ltd., for renovations, additions and mechanical alterations to six Parks facilities, for a total cost of \$566.079.

5. Riverway Golf Course

The Municipal Manager submitted a report from the Director Recreation and Cultural Services requesting approval to enter into a contract with Golf Design Services for the continued development of the Riverway Golf Course. Work will include rough shaping, installing materials, respreading topsoil, fine grading and planting services and slopes of greens, tees and fairway bunkers. This also includes four target greens in the driving range, a combination putting and chipping green behind the ninth green and a smaller putting green by the tenth tee.

The Municipal Manager recommended:

1) THAT approval be given to enter into a contract with Golf Design Services Ltd. in the amount of \$288,300 for the continued development of Riverway Golf Course as outlined in the report.

 Rezoning Reference No. 38/90 4779 and 4791 Kingsway;
 6209 and 6237 McMurray Avenue and 4760 and 4780 Hazel Street

The Municipal Manager submitted a report from the Director Planning and Building Inspection requesting Council authority to forward Rezoning Reference No. 38/90 to a Public Hearing on 1990 November 20.



The purpose of the rezoning bylaw amendment is to provide for development of an 18-storey commercial building comprising a high rise office tower over an office/retail/restaurant podium with full underground parking. The development is consistent with the Metrotown Development Plan.

The Municipal Manager recommended:

- 1) THAT the introduction of a Highway Exchange Bylaw be authorized according to the terms outlined in Section 4.3 of the report, contingent upon the granting by Council of First and Second readings of the subject Rezoning Bylaw.
- 2) THAT a rezoning bylaw be prepared and advanced to First Reading on 1990 November 05 and to a Public Hearing on 1990 November 20 at 7:30 p.m.
- 3) THAT the following be established as prerequisites to the completion of the rezoning:
 - a) The submission of a suitable plan of development.
 - b) The deposit of sufficient monies to cover the costs of all services necessary to serve the site and the completion of a servicing agreement covering all requisite services. All services are to be designed to Municipal standards and constructed in accordance with the Engineering Design. One of the conditions for the release of occupancy permits will be the completion of all requisite services.
 - c) The installation of all electrical, telephone and cable servicing, and all other wiring underground throughout the development, and to the point of connection to the existing service where sufficient facilities are available to serve the development.
 - d) The submission of an undertaking to remove all existing improvements from the site within six months of the rezoning being effected but not prior to Third Reading of the Bylaw. In the event that existing improvements on the site are vacant and considered to be unsafe, unstable, and a hazard to life, the Fire Prevention Office may recommend immediate demolition of such improvements and removal of the resultant debris prior to Third Reading.
 - e) The consolidation of the net project site into one legal parcel.
 - f) The granting of any necessary easements.
 - g) The dedication of any rights-of-way deemed requisite.
 - h) Completion of the Highway Exchange Bylaw.
 - i) The deposit of the applicable charge of \$0.50 per gross building square foot to go towards the acquisition of public open space in Metrotown.
 - j) The deposit of the applicable charge of \$0.306 per gross building square foot to go towards the cost of pedestrian overpasses of Kingsway in Metrotown.
 - k) Provision of finished community services space with appropriate lease arrangements and protected by covenant for use by non-profit community organizations.


