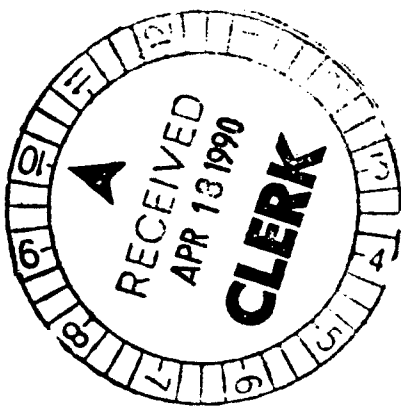
We the undersigned do hereby petition the Municipal Council to construct as a Local Improvement:
