1. Mr. Steve Mancinelli, 5610 East Georgia Street, Burnaby, B.C. appeared before Council expressing frustration in his inability to have access to Council Members and the Municipal Hall outside regular office hours.

The speaker suggested that three "part time" aldermanic positions be eliminated and be replaced with two full time aldermen accessible from 8:00 a.m. to 5:00 p.m. and 1:00 p.m. to 9:00 p.m. each week day. In addition Mr. Mancinelli suggested that Council implement a public workshop process to increase public input into major projects such as the Oakalla lands and B.C. Hydro's Edmonds development.

2. Mr. Robert Davenport, 7345 Brayside Drive, Burnaby, B.C. appeared before Council to express support for the installation of speed bumps in the lane behind Barnet Road.

The speaker advised that the current application for speed bumps is the result of two years of effort to control speeding in the lane. The desire for speed control is the result of an extreme concern on the part of area residents for the safety of their children.

The speaker advised there is full and complete support for the control of speeding in the neighbourhood and the speaker concluded by requesting Council allow the petition to install speed bumps to proceed.

Alderman Begin retired from the Council meeting at 7:25 p.m.

3. Mrs. Bev Mikl, 1310 Fell Avenue, Burnaby, B.C. appeared before Council to request a refund in full of monies paid for the construction of Charles Street which has now been abandoned by the Municipality.

The speaker advised that previously, when construction of the roadway was planned, Mr. and Mrs. Mikl paid the Municipality \$16,725. and gave 33 feet of property toward the road right-of-way. In view of the cancellation of the road construction Mrs. Mikl is now requesting a refund in full of the funds paid.




