Each Mobile Poll will be staffed by a Deputy Returning Officer and three Poll Clerks.

The legislation permitting Council to provide for Mobile Polls is contained within Section 91 of the Municipal Act as follows:

MOBILE POLL

91. A Council may provide by bylaw for the establishment of one or more mobile polls to be held at locations designated in the bylaw. The bylaw shall specify the hours that the mobile poll will be opened at each place.
