RECOMMENDATION:

1) THAT the regularly scheduled Public Hearing dates for 1991 be set for:

1991 JANUARY 29	1991 JULY 23
1991 FEBRUARY 19	1991 AUGUST 20
1991 MARCH 26	1991 SEPTEMBER 24
1991 APRIL 30	1991 OCTOBER 29
1991 MAY 28	1991 NOVEMBER 26
1991 JUNE 25	1991 DECEMBER 17

R E P O R T

Each year at about this time, the Planning and Building Inspection Department brings forward a recommendation that Council set the dates for the regularly-scheduled Zoning Public Hearings for the coming year. Commencing in 1987, Council concurred in a recommendation that Hearings be scheduled for each of the twelve months of the year.

The Public Hearings proposed in this report for February, April, June, August, October and December 1991 will deal with the most recent group of rezoning applications forwarded for consideration under the usual bi-monthly reporting schedule. The remaining Public Hearing dates in January, March, May, July, September and November would be available for other cases, such as those previously being processed, and if it is found unnecessary to hold a Public Hearing in these months, the scheduled Hearing would be cancelled.

The Planning and Building Inspection Department requests that the first regularly scheduled Public Hearing be set for 1991 January 29 and that the remaining Hearings be held on the following dates:

1991 FEBRUARY 19	1991 AUGUST 20
1991 MARCH 26	1991 SEPTEMBER 24
1991 APRIL 30	1991 OCTOBER 29
1991 MAY 28	1991 NOVEMBER 26
1991 JUNE 25	1991 DECEMBER 17
1991 JULY 23	

These dates will allow for the appropriate period between Council's consideration of the Rezoning Report and the Public Hearing to facilitate the preparation of the Zoning Bylaw and the necessary Public Hearing notification process. They will also give sufficient time for report preparation, which must be accomplished between the application deadline and the corresponding Council Meeting at which the rezoning series will be considered.
