REPORT

Further to the petition received by Council on 1990 April 09 concerning the above-noted property, we would advise as follows.

On 1990 April 06 an inspection was conducted on the subject property while in the presence of Ms. Helen Maggs. Ms. Maggs appears as the first person on the petition and has complained to the Municipality in previous years concerning the same property. In each case the property has been cleared of debris in accordance with the Burnaby Unsightly Premises Bylaw.

The property is vacant, undeveloped, and presently covered with grass approximately 10 - 20 cm high, some blackberry vines, and several small, sprouted trees. A mound of dirt, approximately one to two meters high is located near the 16th Avenue border. There was a small amount of debris noted on the property including one piece of electrical cable, several pieces of discarded gypsum board, some broken concrete blocks and a small amount of discarded wood. No evidence of rodents were noted at the time of inspection.

A certified letter was sent to the owner of the property advising him to have the property brought into compliance with the Burnaby Unsightly Premises Bylaw on or before 1990 May 15. The owner was also encouraged to keep the vegetation cut during the spring and summer growing season. Should the property not be brought into compliance by the date specified the Municipality will have the debris removed from the property as provided in the Unsightly Premises Bylaw and charge the costs to the property owner.
