1. Ms. Rebecca Raby, 3833 Venables Street, Burnaby, B.C., Internal Relations Officer, Simon Fraser University and Virginia Rachel, Woman's Study Forum representative, Simon Fraser University appeared before Council to request support for their proposal to freeze tuition fees at colleges and universities in British Columbia.

The speakers contend that the proposed 6% fee increase in 1990 will bring the total fee increases in the last 10 years to 189%. This is placing an undue hardship on students and is creating an elitist atmosphere in the post-secondary education institutions in the Province.

The Simon Fraser Student Association is requesting Council's support for an immediate tuition freeze at B.C. colleges and universities, support for a Provincial Royal Commission on post secondary education to map out a long range plan to meet a variety of social and economic needs, participation and/or a presentation at a community forum to be sponsored by the student association and to declare January 17 - 23 "Freeze the Fees Week" in the Municipality of Burnaby.

Arising from the discussion Alderman Corrigan was granted leave by Council to introduce the following motion:

MOVED BY ALDERMAN CORRIGAN: SECONDED BY ALDERMAN SAWICKI:

"THAT

WHEREAS there have been substantial increases in university and college tuition fees over the past ten years, while there has been a proportional decrease in direct and indirect Provincial and Federal fundings;

AND WHEREAS the Council of the Municipality of Burnaby is seriously concerned that higher education is becoming out of reach for the majority of our citizens;

THEREFORE BE IT RESOLVED that the Honourable Bruce Strachan, Minister of Advanced Education, Training and Technology, be requested to freeze further increases to tuition and that Provincial funding be increased to meet the reasonable budgetary needs of the universities and colleges."

CARRIED UNANIMOUSLY

2. Mr. Bill Marshall, Administrative Coordinator, Wildlife Rescue Association of B.C. appeared before Council to request financial assistance for the Wildlife Rescue Association's activities in Burnaby. The Association operates from facilities on Burnaby Lake and in 1989 treated 727 injured or orphaned animals from the Municipality of Burnaby. The Association is growing at a rate of approximately 10% per year and budget requirements for 1990 are approximately \$150,000.00. The Association does not receive funding from any level of government and operates with six paid staff members and 125 volunteers.


9. (Mrs.) J. McCaffery, 1989 December 14 Re: Payment on property taxes on a monthly basis


