1. Mr. Ronald J. Brown, Chair, Burnaby Public Library Board, residing at 7132 Paulus Court addressed members of Council advising that he was accompanied by Mr. Paul Whitney, Chief Librarian. Approval and funding for the \$5,000 prize was obtained in 1985 from the Parks and Recreation Commission and the mandate of the Rhododendron Competition Committee was to establish rules and guidelines, to recommend judges, to administer the competition and to promote the new varieties.
 - Mr. Allan Goddard, Chair, Burnaby Beautification Committee, 7150 Jubilee Avenue addressed members of Council and advised that the first Rhododendron Festival was held in 1989 May. In 1991, the Third Annual Rhododendron Festival will be held at the James Cowan Centre on Sunday, 1991 May 05 from 10:00 a.m. until 4:00 p.m. with free admission to all.

"WHEREAS municipalities across Canada are incurring increased costs for environmental programs including in particular the costs of recycling programs;

AND WHEREAS the 'After Markets' for many items which are recyclable through Blue Box programs have not materialized or are highly unstable, resulting in municipalities assuming the burden of these increased costs of operating Blue Box programs;

AND WHEREAS Bell Canada, through its association with OMMRI is encouraging municipalities to collect its telephone directories in Blue boxes and otherwise for recycling;

AND WHEREAS corporations like Bell Canada who profit from the delivery of a service or product must take responsibility for the full costs associated with these services and products under the environmental concept of "cradle to grave";

BE IT RESOLVED THAT the City of Nepean hereby requests the support of the Federation of Canadian Municipalities to demand that Bell Canada and their sister telephone companies across Canada assume the full costs of collecting, handling the recycling of their used telephone directories and to seek the involvement of the CRTC in requiring such a commitment from Bell Canada for the 1991 telephone directory distribution."

A note appended to this item of correspondence advises that at present, Burnaby citizens have the opportunity to recycle telephone directories either through the Blue Box Program or at the Still Creek Depot. Both of these services are a cost to Burnaby and therefore it would be appropriate for Council to approve the motion as submitted by the City of Nepean.



8. Letter from Mr. Alan Parker which Appeared on the Agenda for the February 04 Meeting of Council Royal Oak/Kingsway Intersection

> The Municipal Manager submitted a report from the Director Engineering responding to concerns raised by Alan J. Parker, 5267 Carson Street in correspondence received by Council at its meeting of 1991 February 04. Mr. Parker contended that the intersection of Royal Oak Avenue and Kingsway is a hazardous intersection and overdue for improvement.

Staff concurred that this intersection has a significant accident record and believe that widening the approaches on each leg of the intersection to accommodate opposed left turn chanelization with corresponding signal upgrading would best address the accident

A study of traffic conflict incidents was completed in 1990 and the study recommended prohibition of left turns from Royal Oak Avenue during the p.m. peak as a cost effective interim action. However, staff advise that such a prohibition may well overstress other intersections, especially the signal at Imperial and Royal Oak Avenue. Accordingly, staff have been accumulating additional traffic count data in order to estimate the requirements arising from this left turn prohibition. Staff have also been monitoring redevelopment in the area and it now appears that Burnaby may soon obtain sufficient right-of-way dedication to enable implementation of left turn channelization on the Royal Oak Avenue approaches to the intersection. Once clarified, staff will report back to Council via the Traffic Safety Division with recommendations for positive action.

The Municipal Manager recommended:

Staff are currently participating in the GVRDRTAC and Multi-Family Task Force to identify ways and means of providing efficient and safe recycling service to multi-family dwellings.

Staff advised that they will be in a position to make recommendations on the implementation of a system by June which, upon approval, would tie into a system start-up for late 1991, early 1992.

Staff advise that a development proposal for a seven storey building on a vacant commercial lot in the C3 Zone on Hastings Street has been submitted for preliminary plan approval and the proposal conflicts with the Community Plan "Village Centre" objectives of the Burnaby Official Community Plan and the Hastings Street Area Plan in terms of height, density and land use.

Staff propose to work with the owner to prepare a development scheme more in keeping with the Community Plan utilizing CD zoning to be the subject of a further report to Council.

13. Intersection Configuration 19th Avenue at Rumble Street

The Municipal Manager submitted a report from the Director Planning and Building Inspection responding to Council's request for information concerning the future role of Rumble Street in relation to the Griffiths/19th Avenue Connector. The report concludes by advising that based on a recent analysis, the current design for the realignment for the 19th Avenue/Griffiths Avenue intersection with Rumble Street is considered the optimal alternative. As a result of the natural growth in the area, there is a strong demand for access between the south slope and both the Edmonds Towncentre Areas and south east Burnaby. The realignment will reduce excessive traffic on Rumble Street caused by redirecting vehicles travelling to Kingsway and thus provide the best balance between two often conflicting needs for relief from traffic and for local access.

The alternative of closing Rumble Street at Griffiths is not recommended as it would reduce traffic volumes in a limited section of Rumble while increasing traffic on Gilley Avenue and restricting access for local residents.

The Municipal Manager recommended:

14. Board of Variance Appeal 7329 Braeside Drive

The Municipal Manager submitted a report from the Municipal Clerk providing a response to correspondence received from Mr. Charles Purpora questioning procedures regarding his application to the Board of Variance for the property located at 7313 Braeside Drive.

The report briefly described the function of the Board and provided the specifics regarding the appeal in question. The Clerk advised that requirements established under the Burnaby Board of Variance Bylaw with respect to the general operation of the Board of Variance in areas such as notification and hearing procedures have worked well in most instances.

It has not been the Board's practice to conduct a site inspection for each and every appeal but rather it is left to each Board Member's discretion as to whether a site inspection would assist them in making their decision. Should Council wish to reduce or alter the authority of the Board then Burnaby would have to petition the Minister of Municipal Affairs to amend the provisions of the Municipal Act.

In addition, if directed by Council to do so, staff will recommend to the Board that the January hearings be held on the second Thursday of the month (the Board of Variance hearings are held on the first Thursday of each month) to alleviate possible problems which may arise as a result of the holiday season.



NOTICE OF MOTION

Alderman Lawson gave notice of her intention to introduce the following motion at the 1991 February 18 meeting of Council:

"WHEREAS loss and degradation of habitat is the greatest threat to the world's wildlife, and;

WHEREAS Burnaby Lake is a nature park and wildlife sanctuary which is the last major freshwater lake (as well as being one of the few remaining freshwater marsh habitats) in the Lower Mainland, which serves as an important link in the Pacific Flyway as a safe resting and feeding stopover for migrating birds each spring and fall, as well as being "home" to over 200 species of resident and visiting birds and a variety of mammals, reptiles and amphibians, and;



WHEREAS the Burnaby Fish and Game Club, Burnaby Boy Scouts, and a neighbouring family have erected wood duck boxes in and around the sanctuary; and the Burnaby Lake Advisory Association co-sponsors, upgrades, and constructs new trails around the lake's perimeter, and;

WHEREAS Burnaby Lake serves as a nature study area for students and researchers of all ages; as a passive recreational area which includes bird watchers, photographers, artists, canoes, kayakers, walkers and joggers, and equestrians; and has lanes for competitive rowers, canoers and kayakers, and;

WHEREAS, the Greater Vancouver Regional District Parks Department conducts nature interpretive programs for children and adults from the Nature House on the north side of the lake and supports the activities of the Wildlife Rescue Association of B.C. which is situated on the south shore, and;

WHEREAS silt from increased urbanization has accumulated in the lake (some of the 1973 Canada Summer Games dredgeate has, apparently, also shifted from the islands to other parts of the lake) and introduced water plants have colonized, causing an otherwise natural process of eutrophication to accelerate at an alarming rate which is resulting in an ever diminishing lake surface and depth which, in turn, adversely affects current fish and wildlife habitat and endangers the whole freshwater ecosystem of the sanctuary, and;

WHEREAS water quality in the most important tributaries of Still Creek (classified by the Greater Vancouver Regional District as "poor") and Deer Lake (which is also poor) and storm water runoff negatively affect the quality of water in Burnaby Lake, and;

WHEREAS a wildlife sanctuary needs a feeling of tranquility and to be surrounded by greenery to exist and that ambience has begun to be eroded by the unscreened residential development on the south slope of Burnaby Lake, and;

WHEREAS the management plan for the lake, "A Development Programme for Burnaby Lake Regional Park", dated December 1975, has provided excellent direction for development in our contract with the Greater Vancouver Regional District Parks Department which is due for renegotiation in 1991, and;

WHEREAS a nature park and wildlife sanctuary in the center of an urban population of over 1.7 million people is a very unique and precious resource for wildlife, our children and their children;

THEREFORE BE IT RESOLVED, that:

Brunette River, and;

- 1. Staff be requested to establish a contemporary management plan for Burnaby Lake, in collaboration with the Greater Vancouver Regional District, to rejuvenate the value of the park as a freshwater sanctuary with an ecosystem which has maximum biological diversity for fish, wildlife, and flora; a Pacific Flyway stopover for migrating birds; and for education, research and passive recreation, and;
- 2. The management plan should analyze and document physical and ecological changes that are occurring in the lake and park; document widlife habitat changes, utilization, and values; identify compatible types and levels of educational, research, and recreational activities; and establish priorities and actions for rejuvenation of the lake in an environmentally sensitive way, ambience retention, and long-term management of the lake and nature park, and;

- 3. The management plan be concluded well in advance of the contract renegogiations with the Greater Vancouver Regional District, and;
- 4. A schedule of the proposed work and action plan be presented to Council, and;
- 5. A copy of the motion be sent to the Parks and Recreation Commission and the Greater Vancouver Regional District Parks Board.

NEW BUSINESS

Alderman Drummond retired from the Council Chamber at 9:16 p.m.

Alderman Rankin

Alderman Rankin advised Council that he had been contacted by the Columbia Housing Advisory Association regarding the development of a housing cooperative of approximately 80 units on the Municipally owned site 6A in the Cariboo Heights Subdivision. Apparently the CMHC allocations to British Columbia in 1990 were not sufficient to enable the project to proceed and therefore the Columbia Housing Advisory Association submitted a draft letter to Alderman Rankin for Council's consideration to be forwarded to the Honourable Alan Redway, Federal Minister of Housing.

MOVED BY ALDERMAN RANKIN: SECONDED BY ALDERMAN EVANS:

"THAT staff work with the Mayor to ensure that the information in the draft letter submitted by Columbia Housing Advisory Association is accurate, and further that the letter be forwarded to the Federal Minister of Housing."

His Worship, Mayor W.J. Copeland advised that he was in receipt of invoices for membership dues from both the Federation of Canadian Municipalities and the Union of British Columbia Municipalities.

Alderman Drummond returned to the Council Chamber at 9:22 p.m. and took his place at the Council table.

MOVED BY ALDERMAN CORRIGAN: SECONDED BY ALDERMAN YOUNG:

"THAT the Federation of Canadian Municipalities membership dues in the amount of \$14,839 be paid."

MOVED BY ALDERMAN EVANS: SECONDED BY ALDERMAN CORRIGAN:

"THAT the Union of British Columbia Municipalities membership dues in the amount of \$10,975.31 be paid."

CARRIED UNANIMOUSLY

Arising out of the discussion with respect to increases in membership dues, Alderman Rankin was granted leave by Council to introduce the following motion:

MOVED BY ALDERMAN RANKIN: SECONDED BY ALDERMAN EVANS:

"THAT the UBCM and FCM be instructed to provide their budgets and justification for increases in membership fees when the invoices are forwarded on an annual basis."

Worship, Mayor W.J. Copeland

His Worship, Mayor W.J. Copeland advised that he was in receipt of correspondence from the Vancouver City Manager who confirmed that Burnaby's renegotiated cost sharing portion of 21% had been further discussed and subsequently reduced to 16% which equates to an approximate net savings to Burnaby of \$70,000. His Worship, Mayor W.J. Copeland commended the efforts of Alderman Corrigan and staff in achieving an acceptable cost sharing portion for Burnaby.

His Worship, Mayor W.J. Copeland further advised of correspondence received from the Mayor of the City of Richmond regarding appointments to the North Fraser Harbour Commission. Mayor Copeland reconfirmed Council's position of continued support for Mr. Froese as Burnaby's appointee to the North Fraser Harbour Commission.

INQUIRIES

There were no inquiries brought before Council at this time.
