RECOMMENDATIONS:

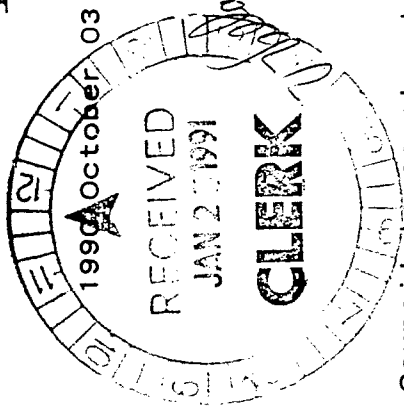
