3. Province of B.C., Ministry of Regional and Economic Development, Minister, 1991 January 31 Re: Awarding of grant from Community Organizations for Economic Development Program - 1990 Core Funding

> A letter dated 1991 January 31 was received from the Honourable Bud Smith, Minister of Regional and Economic Development advising that Burnaby has received funding from the Community Organizations for Economic Development program in the amount of \$32,250. The award is the result of an application submitted for 1990 Core Funding.

A staff notation appended to this item of correspondence advises that the Provincial Government through the COED Program assists municipalities to fund initiatives that support economic development. Burnaby's economic development coordination function has been the recipient of program grants in recent years that have helped offset the cost of providing coordination services. The contribution of \$32,250 at this time relates to the Provincial Government's recognition of services provided in 1990 and is for a sum slightly greater than that expected at the time of application. The amount in excess of our 1990 projects (slightly over \$2,000) will be credited to 1991 revenue and staff will submit an application for core funding under the COED Program for 1991 at the appropriate time.

 Canada, Minister of National Health and Welfare, Minister, 1991 February 26, Re: Impact of Bill C-61 - Forfeiture of Crime-derived Assets

> A letter dated 1991 February 26 was received from the Federal Minister of National Health and Welfare responding to Council's concerns regarding the impact of Bill C-61 which provides for the forfeiture of crime-derived assets. The Minister advises that only those prosecutions which are conducted on behalf of the Attorney General of Canada may result in forfeiture of assets to the Federal Government. The monies forfeited or derived from forfeited assets are deposited in the Consolidated Revenue Fund.

The policy of the National Health and Welfare Ministry is to reimburse all monies seized at the time of the arrest which were paid out by police in the course of undercover purchase of drugs.

5. District of Kitimat, Municipal Clerk 1991 February 27 Re: Resolution regarding Equal Access to Health Care Services

A letter dated 1991 February 27 was received from the District of Kitimat requesting support for a resolution on "Equal Access to Health Care Services". The resolution draws attention to the difficulties encountered by residents of rural British Columbia in travelling to larger centres in other regions to access certain health care services.

 The Great Canadian Stamp Company Inc., 1991 February 26 Re: Burnaby Business Licencing Costs

While the first year licence fee of \$327.00 was higher than most due to the administratie and inspectional costs of ensuring public and health and safety, the renewal fee of \$212 is similar to the fees charged by other communities in the G.V.R.D. The delay in the approval in the licence resulted from the building not meeting all the building code requirements. The Planning and Building Inspection Department advises that these problems were only recently resolved, thus enabling the issuance of the licence.
