The speaker expressed dismay at the attrition of natural woods throughout the community. Mrs. Elwood reviewed various naturally wooded sites which have been lost to various developments during the past several years.

Mrs. Elwood stated that the greenspace areas which disguise developments do not provide an adequate natural habitat for the various forms of wildlife found in Burnaby. The delegation contends that provision of natural greenspace is necessary for the health of the community.

In conclusion, the speaker requested Council declare a moratorium on any development of greenspace until an adequate assessment through study and public input into community needs regarding greenspace has been completed.

- 3. Mr. Harvey Elder, President, East Burnaby Ratepayers' Association, appeared before Council to discuss development of extended care facilities and community centres in the community. In addition, the speaker expressed concerns with regard to the lack of a regional perspective in the development of transportation plans. Mr. Elder urged Council to look at the region as a whole as opposed to being concerned only with the areas within Burnaby's borders. The speaker concluded by requesting development of an advisory committee for East Burnaby to promote public participation in future development of the neighbourhood.
- 4. The delegation withdrew prior to the Council Meeting.
- 5. Mr. John Stewart and Mr. David Clark, Race Organizers, appeared before Council to discuss highlights of the Canadian International Outboard Grand Prix proposed to be held at Barnet Marine Park. Mr. Stewart discussed the economic impact of the race through a comparison of the Winnipeg event. Winnipeg has received a positive direct impact of \$2.0 million and an indirect impact of \$4.0 million. It is felt that Burnaby has the potential for a third larger return.

The race is a world class event and draws spectators from a large geographic area. The race is telecast on the T.S.N./E.S.P.N. network and features approximately 6 minutes per hour on the host community.

The organizers have plans to incorporate both cultural and entertainment aspects into the program, certain improvements will also be made to the park area including docks facilities which would be retained on the site. The race has a good reputation as a very safe event and would not create a lot of noise or disturbance in the neighbourhood.
