1. Mr. Mark Angelo and representatives of the B.C.I.T. Staff Society appeared before Council to discuss the impact of reduced Provincial funding on B.C.I.T. and other post secondary education institutions.

Although the 1991 budget shortfall is only 1.5 percent, the cumulative affect of chronic underfunding has resulted in program cuts, enrollment cutbacks and a loss of teaching positions which has severely impaired the ability of the staff to deliver the educational programs.

The speaker expressed concern about the effect of the rising cost of an education on the students and the subsequent debt load upon completion of a two year program.

As a result of these concerns the Staff Society is requesting Council's support in submitting a request to the Provincial government to review B.C.I.T.'s 1991 budget and its impact on young people throughout the province and the cumulative effect of budget reductions over the past 10 years.

Alderman Redman entered the Council Chamber at 7:23 p.m. and took her place at the Council table.

Arising from the discussion Alderman Rankin was granted leave by Council to introduce the following motion:

"THAT WHEREAS the Municipal Council of Burnaby recognizes the role of B.C.I.T. as an educational resource and job training centre for young people and mature students;

THEREFORE BE IT RESOLVED THAT the Ministry of Advanced Education, Training and Technology be requested to review the 1991 operating and capital allocation for B.C.I.T. and review the long-term impact of chronic underfunding of B.C.I.T. and that copies of this resolution be forwarded to the Premier of British Columbia, Minister of Finance and Burnaby Members of the Legislative Assembly."

2. Mr. Peter Walker, 3762 Nico Wynd Drive, Surrey, B.C. appeared before Council to request permission to hold an environmental concert on the Oakalla lands on 1991 September 15. The event would be held from 12 noon to 6 p.m. and would include tours of Oakalla Prison, a Sockeye Salmon barbecue, street entertainers, a Beach Boys concert and other guest celebrities. The cost of tickets would be \$18 per person with children under 12 free. Mr. Walker will contribute \$1 from each ticket sold toward the cleanup of Deer Lake and additional donations will be provided to the Burnaby Boy Scouts and the Burnaby Kinsmen. Parking will be provided at B.C.I.T. with shuttle buses providing transportation to and from Oakalla. Mr. Walker requested Council authorize issuance of a permit to hold the event.

Arising from the discussion Alderman Drummond was granted leave by Council to introduce the following motion:

The Municipal Manager submitted a report from the Acting Chief Public Health Inspector prepared in response to Council's request for detailed information regarding the possible health risk associated with living in close proximity to high tension power lines and to clarify the issue of jurisdiction over high tension power lines.

Municipal staff advised that currently there is a great deal of research being conducted pursuing the association between cancer and exposure to electromagnetic fields. However, it will likely be 1994 or later before the association between electromagnetic fields and cancer can be substantiated or refuted.

In the matter of jurisdiction over the property on which the high tension lines are constructed, the lines are located entirely on the Vancouver side of Vancouver/Burnaby boundary and are utilizing space within the right-of-way owned by the City of Vancouver.

The Municipal Manager recommended:
