Alderman Drummond arrived at the Council Meeting at 7:03 p.m. and took his place at the Council table.

Mr. Paul Murphy, 7545 Burris Street, Burnaby, accompanied by his neighbour, Mr. David Ogilvie, 7561 Burris Street addressed Council advising that the two properties located at 7545 and 7561 Burris Street, together with 5765 Buckingham are the three remaining properties from an assembly of six properties that were submitted for a subdivision proposal approximately one year ago. The proposal envisioned a cul-de-sac access into a subdivision of some nine or ten lots.

Alderman Rankin arrived at the Council Meeting at 7:06 p.m. and took his place at the Council table.



The delegation advised that he had approached Council one year ago seeking a suitable compromise to the cul-de-sac versus "panhandle" design to ensure a quality subdivision proposal.

In 1990 October, a preliminary plan approval was indicated by the Planning Department based on the conceded subdivision application provided by Buckingham Estates to come up with "panhandle" lots. The speaker was dismayed with the fact that the Planning Department now advise that an extremely technical environment study must be conducted.

Alderman Redman arrived at the Council Meeting at 7:08 p.m. and took her place at the Council table.

In conclusion Mr. Murphy questioned why the subdivision proposal was taking so long to complete and further suggested that there has been no confirmation that the current subdivision plan or any subdivision plan will be approved and that it will take another approximately eight to twelve months to be determined.

Mr. David Ogilvie, 7561 Burris Street, Burnaby addressed Council advising that when he purchased his property three years ago he was aware that the property had subdivision potential and subsequently pursued a subdivision application with his neighbours.

Arising out of the history of the subdivision proposal that Mr. Ogilvie provided to Council, he further expressed his confusion and frustration with the lengthy process and the fact that an environmental study has now been ordered by the Planning Department, at the applicants' expense, which could take up to twelve months to complete.

In conclusion Mr. Ogilvie advised that time, effort and money have been spent on what he believes to be a potentially beautiful subdivision and therefore requested that Council become involved in the subdivision process, both at the staff level and with the neighbourhood.

Arising from a discussion on this matter, Alderman Drummond was granted leave by Council to introduce the following motion:

It is in that vein that the writer expressed strong support for Council's proposed motion for a management plan that would preserve Burnaby Lake as a freshwater sanctuary which has maximum biological diversity.

4. Northwest Wildlife Preservation Society, Executive Director, 1991 February 11 Re: Rejuvenation of Burnaby Lake

A letter dated 1991 February 11 was received offering the Society's unqualified support for Council's proposed motion regarding the rejuvenation of Burnaby Lake which entails a contemporary management plan for the lake with the aim of rejuvenating the vital wildlife refuge.

Alderman Doreen Lawson then presented Council with a slide presentation complimentary to the Notice of Motion regarding the rejuvenation of Burnaby Lake



"THAT WHEREAS loss and degradation of habitat is the greatest threat to the world's wildlife, and;

WHEREAS Burnaby Lake is a nature park and wildlife sanctuary which is the last major freshwater lake (as well as being one of the few remaining freshwater marsh habitats) in the Lower Mainland, which serves as an important link in the Pacific Flyway as a safe resting and feeding stopover for migrating birds each spring and fall, as well as being "home" to over 200 species of resident and visiting birds and a variety of mammals, reptiles and amphibians, and;

WHEREAS the Sapperton Fish and Game Club, Stoney Creek School students, and Fisheries and Oceans (Canada) Salmonid Enhancement Program have succeeded in reintroducing coho salmon into the system after an absence of 19 years; and the Ministry of Environment, Fisheries Management, annually plants steelhead, rainbow, and coastal cutthroat trout in the adjacent waters of Deer Lake and Brunette River, and;

WHEREAS the Burnaby Fish and Game Club, Burnaby Boy Scouts, and a neighbouring family have erected wood duck boxes in and around the sanctuary; and the Burnaby Lake Advisory Association co-sponsors, upgrades, and constructs new trails around the lake's perimeter, and;

WHEREAS Burnaby Lake serves as a nature study area for students and researchers of all ages; as a passive recreational area which includes bird watchers, photographers, artists, canoes, kayakers, walkers and joggers, and equestrians; and has lanes for competitive rowers, canoers and kayakers, and;

WHEREAS, the Greater Vancouver Regional District Parks Department conducts nature interpretive programs for children and adults from the Nature House on the north side of the lake and supports the activities of the Wildlife Rescue Association of B.C. which is situated on the south shore, and;

WHEREAS silt from increased urbanization has accumulated in the lake (some of the 1973 Canada Summer Games dredgeate has, apparently, also shifted from the islands to other parts of the lake) and introduced water plants have colonized, causing an otherwise natural process of eutrophication to accelerate at an alarming rate which is resulting in an ever diminishing lake surface and depth which, in turn, adversely affects current fish and wildlife habitat and endangers the whole freshwater ecosystem of the sanctuary, and;

WHEREAS water quality in the most important tributaries of Still Creek (classified by the Greater Vancouver Regional District as "poor") and Deer Lake (which is also poor) and storm water runoff negatively affect the quality of water in Burnaby Lake, and;

WHEREAS a wildlife sanctuary needs a feeling of tranquility and to be surrounded by greenery to exist and that ambience has begun to be eroded by the unscreened residential development on the south slope of Burnaby Lake, and;

WHEREAS the management plan for the lake, "A Development Programme for Burnaby Lake Regional Park", dated December 1975, has provided excellent direction for development in our contract with the Greater Vancouver Regional District Parks Department which is due for renegotiation in 1991, and;

WHEREAS a nature park and wildlife sanctuary in the center of an urban population of over 1.7 million people is a very unique and precious resource for wildlife, our children and their children;

THEREFORE BE IT RESOLVED, that:

1. Staff be requested to establish a contemporary management plan for Burnaby Lake, in collaboration with the Greater Vancouver Regional District, to rejuvenate the value of the park as a freshwater sanctuary with an ecosystem which has maximum biological diversity for fish, wildlife, and flora; a Pacific Flyway stopover for migrating birds; and for education, research and passive recreation, and;

- 2. The management plan should analyze and document physical and ecological changes that are occurring in the lake and park; document wildlife habitat changes, utilization, and values; identify compatible types and levels of educational, research, and recreational activities; and establish priorities and actions for rejuvenation of the lake in an environmentally sensitive way, ambience retention, and long-term management of the lake and nature park, and;
- 3. The management plan be concluded well in advance of the contract renegotiations with the Greater Vancouver Regional District, and;
- 4. A schedule of the proposed work and action plan be presented to Council, and;
- 5. A copy of the motion be sent to the Parks and Recreation Commission and the Greater Vancouver Regional District Parks Board."

"THAT the motion regarding the rejuvenation of Burnaby Lake be **REFERRED** to the Environment and Waste Management Committee."

The proposal for area specific zoning for Brentwood Park was based on an approach which balances the desire of many residents to protect the low scale character of housing and the desire of other residents to be able to develop their land to a reasonable extent to meet changing household needs or current living standards as revealed in a recent survey of the area. The issues related to the bulk of housing are addressed by a combination of four regulations pertaining to floor areas and height and additional regulations to maintain the character of the streetscape are also proposed.

The report further identifies the initiatives taken by the regional district and more specifically, by the Municipality which are intended to address the question of reducing the contamination of our receiving waters.

16. Storage of Recreational Vehicles and Boats in Residential (R) Districts

The Municipal Manager submitted a report from the Director Planning and Building Inspection proposing an amendment to the Burnaby Zoning Bylaw relating to the storage of recreational vehicles and pleasure boats in the residential (R1 - R5, R9) districts.

Staff advise that in proposing this text amendment to the Zoning Bylaw, careful consideration was given to the desire of owners to park their vehicle and/or boat on their property for reasons related to convenience and cost and to the desire to minimize the aesthetic impacts of such parking on neighbours and on the streetscape. The amendment would update the bylaw in terms of allowing for the parking of larger recreational vehicles and/or boats that are already commonly found throughout Burnaby.

The Municipal Manager recommended:

- 1. THAT Council authorize the Municipal Solicitor to prepare a bylaw amending the Burnaby Zoning Bylaw to permit the parking of one recreational vehicle and one pleasure boat in the open in the R1 R5 and R9 Residential Districts, provided that
 - a. the maximum combined length does not exceed 12.0 metres (39.37 feet);
 - b. for lots with one street frontage and for corner lots, no parking is located in the area between the front lot line and the dwelling, nor within the required side yards, nor be located closer than 1.2 metres (3.94 feet) to the side lot lines in the rear yard;
 - c. for through lots, no parking is permitted in the required front yards or required side yards, nor in the area between the required front yard and the face of the dwelling oriented to the street from which the dwelling is addressed:
 - d. on a corner lot or through lot, the parking must be screened by compact evergreen planting at least 1.8 metres (5.91 feet) in height to visually obscure the view from the closest abutting street;
 - e. parking is subject to the vision clearance provisions of Section 6.13 of the Bylaw pertaining to street and lane corners;
 - f. if there is no physical access to both the rear <u>and</u> side yard, either one recreational vehicle or one pleasure boat not exceeding 6 metres (19.69 feet) in length may be located

- . on the front driveway: not less than 1.2 metres (3.94 feet) from the side lot lines and not less than 1.8 metres (5.91 feet) from the front lot line; and must be screened by compact evergreen planting at least 1.8 metres (5.91 feet) in height to visually obscure the view from any abutting property, subject to the vision clearance provisions of Section 6.13 of the Burnaby Zoning Bylaw; or
- . to the side of the front driveway: not less than 1.2 metres (3.94 feet) from the side lot lines and not less than 1.8 metres (5.91 feet) from the front lot line; and must be screened by compact evergreen planting at least 1.8 metres (5.91 feet) in height to visually obscure the view from any abutting property and from the abutting street, subject to the vision clearance provisions of Section 6.13 of the Burnaby Zoning Bylaw:
- 2. THAT Council authorize the bylaw to be forwarded to First Reading on 1991 March 04 and to a Public Hearing on 1991 March 26 at 7:30 p.m.
