Burnaby has experienced a decrease in traffic related injuries from 23% to 19% between 1989 and 1990. Mr. Fourchalk and Mr. Pachal then presented Mayor Copeland with a special Certificate of Merit from the Canada Safety Council in recognition of zero fatalities during Safe Driving Week, 1990.
