The proposed 65 foot by 74 foot lots would each have an area of only 446.8 ^m (4,810 square feet) and therefore the subject property has no subdivision potential.

Wendy Carr, 39 9000 Ashgrove Crescent, Burnaby, B.C. appeared before Council requesting reconsideration of the decision by the Parks and Recreation Commission to eliminate the "Fitness First" Program at Cameron Recreation Centre. Mrs. Carr submitted a compromise solution to this situation whereby the Fitness First group would operate in the small multi-purpose room of Cameron Recreation Centre allowing the municipality to utilize the large sports hall for different programming. Mrs. Carr proposes to rent the small multi-purpose room or continue on a revenue sharing basis with the municipality.

Arising from the discussion Council agreed that an informal meeting be held between the Parks and Recreation Commission and Council to discuss this problem.
