His Worship, Mayor W.J. Copeland announced that June 04 is Census Day in Canada and requested that citizens of Burnaby cooperate by completing their census information as required.

His Worship, Mayor W.J. Copeland proclaimed the week of 1991 June 02 - 08 as Long Term Care Week in Burnaby; the month of June as Leukemia Awareness Month in Burnaby and the week of 1991 June 16 - 22 as Canadian Occupational Health and Safety Week.

1. Mr. Ken Legge, 5025 Watling Street, Burnaby B.C. appeared before Council to provide a status report on financial arrangements for construction of the Harry Jerome Sports Centre.

The status report is a requirement for issuance of the building permit. The speaker advised of donations committed to the project and noted that a bike auction is planned as a major fund raiser.

Mr. Legge anticipates that the project will be completed within the $1.4\,$ million dollar budget.

Council requested that a financial statement providing confirmation of all donations in kind be submitted prior to issuance of the building permit.

Alderman Redman entered the Council Chamber at 7:18 p.m. and took her place at the Council table.

Council requested that the financial report be provided at the 1991 June 17 regular Council meeting.

2. Mr. Nick DiPalma, 4601 Union Street, Burnaby B.C. appeared before Council to request permission to construct an extension to his home which would exceed the bylaw maximum square footage by 147 sq. ft.

The delegation advised that the Board of Variance has allowed a reduction in the rear yard setback but that the construction still exceeds that bylaw maximum.

Alderman Corrigan retired from the Council Chamber at 7:40 p.m.

Alderman Young retired from the Council Chamber at 7:41 p.m.

The delegation advised that he is aware that Council is not permitted to relax the zoning bylaw, but requests clarification as to the ability to rezone his property to permit the development.

Alderman Corrigan returned to the Council Chamber at 7:46 p.m. and took his place at the Council table.

Council requested that staff work with Mr. DiPalma to try to develop a plan which would conform to zoning bylaw requirements.

His Worship, Mayor W.J. Copeland introduced Mr. David Pye, Refinery Manager, Shell Refinery, Burnaby who is in attendance to provide Council with detailed information on the recent petroleum products spill into Burrard Inlet.

Mr. Pye apologized to Council for the incident and advised that a tremendous effort has been exerted to clean up the spill and that as of Sunday, June 02 the spill has been cleaned up.

Mr. Pye advised that the spill occurred on Thursday, 1991 May 30 between 12 midnight and 2 a.m., as the refinery operators were starting up a splitter unit which had been shut down for maintenance purposes. As the oil was introduced into the unit it spilled out of a temporary line and into Burrard Inlet. The spill continued for approximately one and one half hours before being discovered. Approximately 393 barrels of oil were spilled with less than half of that volume actually travelling into Burrard Inlet. The type of oil which was spilled was a feed stock composed of diesel, jet fuel and a small amount of gasoline and lubricating product, but did not contain any crude oil. The majority of the leak evaporated before causing too much damage.

Alderman Young returned to the Council Chamber at 7:56 p.m. and took his place at the Council table.

Arising from the discussion Alderman Drummund was granted leave by Council to introduce the following motion:

MOVED BY ALDERMAN DRUMMOND: SECONDED BY ALDERMAN EVANS:

"THAT Municipal staff prepare a comprehensive report on the cause of the spill of petroleum products into Burrard Inlet from the Shell Refinery, including the effect on the shoreline and waterways of Burrard Inlet and a description of the new procedures to be put in place by Shell Refinery which will ensure such an incident does not happen again."

His Worship, Mayor W.J. Copeland advised that the Greater Vancouver Regional District has requested that Burnaby permit the oil-soaked debris collected from the spill be disposed of in the Burnaby incinerator.

Arising from the discussion Alderman Corrigan was granted leave by Council to introduce the following motion:

MOVED BY ALDERMAN CORRIGAN: SECONDED BY ALDERMAN LAWSON:

"THAT Burnaby Council concur with the request of the Greater Vancouver Regional District and the Ministry of Environment for disposal of waste from the incident at the Shell Refinery on a one-time-only basis; and further, that the Greater Vancouver Regional District be requested to prepare a report on future programs and policies for disposal of this type of emergency waste."

Council also requested that Municipal staff clarify the type of accelerant used in the incinerator to assist in disposal of the waste.

Alderman Drummond advised that he has discovered a number of rusted drums containing an asphaltic type of petroleum product in the area east of Penzance Drive which may be the result of filling in the area.

The Fire Chief advises that the GVRD Fire Chiefs, Provincial Gas Safety Branch and the propane industry are aware of the concerns as expressed in Mr. Sulmona's letter, and that representatives from these organizations are meeting as a committee to resolve them. A propane bottle exchange program and/or refilling of bottles in a safer manner is one of the alternatives that is presently under consideration.

A senior officer of the Burnaby Fire Department has discussed this matter with Mr. Sulmona.

The Municipal Manager submitted a report from the Director Planning and Building Inspection requesting Council adoption of the Hastings Street area plan and authorizing staff to pursue implementation of the plan. The purpose of the new plan is to replace the existing adopted 1969 high density community plan with a lower density urban "village" concept that will accommodate a district level commercial centre with associated low scale residential development. The report provides a review of the comments received at the public meeting held on 1991 April 29 and includes areas of consideration such as commercial land use, residential land use, parking and heritage buildings.

The Municipal Manager recommended:
