This work is performed on an annual basis and is an essential component of our ongoing pavement management program. The surfaces of older streets are capped with an asphaltic overlay that extends the useful life of the road surface and protects the Municipality's significant investment in its roads infrastructure.

This work order covers the 1991 pavement management program including Contract Nos. 9116 and 9117 and additional preparatory work by municipal forces. Sufficient funds are available in the 1991 - 1995 Capital Budget, Code 08, Street and Lane Rehabilitation.

The 1991 - 1995 Capital Budget includes provision for water-main installation on Sperling Avenue from Winston Street to Claude Street. The project consists of the installation of a new main which will improve the water supply and fire flow protection to surrounding areas. This work order covers the cost of engineering services and the pre-order of special pipe fittings. Sufficient funds are available in the 1991 - 1995 Capital Budget, Code 21, Mains, Pumping Stations etc..

60 30 077 - Sanitary Sewer Pump Station at Keith Avenue/ Joffre Avenue.

Additional Information

Appearing elsewhere on Council's Agenda is an item recommending award of Contract No. 9112 for construction of a sanitary sewer pump station at Keith Avenue/Joffre Avenue. Sewer connections on Joffre Avenue are connected directly to the GVS & DD's main line. The new pump station is required to eliminate the potential for overflowing should the GVS & DD's sewer remain surcharged for extended periods.

Total estimated project cost, including engineering design fees, and other ancillary work by municipal forces is \$195,000.00, of which \$120,000.00 has been previously approved by Council. This work order seeks approval for additional funding of \$75,000.00 required for project completion. Sufficient funds are available in the 1991 - 1995 Capital Budget, under Code 30, Sanitary Sewer Extensions.

Additional Information

The sanitary sewer main through the Central Valley has experienced severe settlement problems due to the surrounding poor soil conditions. Recent TV camera inspections have revealed rapidly deteriorating conditions which require immediate attention to restore the functionality of the system. Provisions for these improvements have been included in the 1991 - 1995 Capital Budget, Code 30 Sanitary Extensions.
