60-55-007 Fire Hall #2 (7578 Edmonds Street)

Charge:

1990-1994 Capital Budget Code 55, Fire Halls

Additional Information: In 1990 August the Corporation retained the services of Inter-Coast Consultants Ltd. to perform a comprehensive roof inspection at Fire Hall #2. The consultant's report indicates that the 20 year old tar and gravel built-up roof has reached the end of its optimum lifespan. It is leaking in several areas and should be replaced at the earliest opportunity.

In October of last year engineering consultants conducted a seismic risk survey of all fire halls in Burnaby. At Fire Hall #2, a number of structural items, including the roof diaphragm, were identified as being deficient and would require upgrading in order to withstand seismic activity. Strengthening of the diaphragm should be done in conjunction with the replacement roof. The proposed work will not compromise additional improvements recommended in the seismic study.

The estimated cost of re-roofing is \$22,000, funds for which are available in the 1990-1994 Capital Budget. It is recommended that the additional cost of \$6,500 required to upgrade the roof membrane be interim financed from the 1991 Capital Contingency
