Residents of the area are not in support of the extension as they feel it will disrupt their neighbourhood with increased vehicular traffic.

Municipal staff advise that the recommendation to extend Kern Avenue is in response to an application to subdivide 7984 Gilley Avenue into four single family lots under the existing R2 Residential District zoning. This layout will provide for the completion of the lanes, Caulwynd Place cul-de-sac and Brynior Drive in accordance with the overall subdivision guideplan which was prepared for this area in 1978 in response to a subdivision application received for the properties to the south. These roads and lanes were not completed at that time as the owner of the subject property did not participate in the subdivision. It is the opinion of municipal staff that the completion of the Brynior Drive road link best serves the public interest, best suits the intended hierarchical road functions within this area and should be required as a condition of subdivision approval.

Hydro and Power Authority. These easements will allow the placement of a switching klosk and two pad-mounted transformer boxes on land within Central Park. The works are required for a municipal beautification project to remove overhead power lines from Patterson Avenue between Kingsway and the Patterson Skytrain Station.

3. Maintenance of Ravine Lands

The Municipal Manager submitted a report from the Director Recreation & Cuitural Services advising Council of the Parks and Recreation Department maintenance program for ravines. Staff advised that once a year ravines and creek beds receive a minimal cleanup. Garbage, debris and dead branches are removed from the creekbeds and disposed of. Dead or unsafe trees in the ravines, but not in the creek beds are cut down and left on the forest floor. Occasionally dead, diseased or unsafe trees along the top of a ravine adjacent to residential areas and roads are cut or moved from the area. If the dry branches are left on the ravine edge, they become a fire hazard and encourage or invite other unwanted dumping along the edges of the undeveloped parklands throughout the municipality. Parks staff are instructed and encouraged to keep the ravines and undeveloped parkland natural and undertake the minimal amount of maintenance necessary to keep them safe.

4. Cutting Practice on Meadow and Grass Areas in Undeveloped Parkland

The Municipal Manager submitted a report from the Director Recreation & Cuitural Services advising Council of the grass cutting practices on undeveloped parkiand areas. Parks and Recreation Department staff advise that approximately 150 acres of manicured turf areas have been reverted to meadow. These areas receive minimal maintenance. The general practice has been to cut this grass and other vegetation twice a year, once in late June and once in the early fail. Cutting twice a year prevents the woody vegetation, salmonberry, blackberry and red aider trees from becoming established, but reduces the herbaceous wild flowers. The twice a year cutting allows staff to remove unwanted garbage before it becomes unsightly.

6. Burnaby's Future Needs for Waterlots and other Parks and Recreation Properties Fronting Burrard inlet

The Municipal Manager submitted a report from the Director Recreation & Cultural Services advising of Burnaby's future needs for wateriots and other parks and recreation properties fronting Burrard Inlet. Burnaby has ownership of five waterlots and leases seven others from the Vancouver Port Corporation. The waterlots under Burnaby ownership were acquired as part of the purchase of the Texaco and Kapoor properties. Staff advise that iands and waterlots abutting Burrard iniet are designated for either Industrial or park and conservation use. An overall goal of the Official Community Pian is to ensure that Burnaby is provided with a balanced diversity of land uses within a framework that meets the municipality's present and future needs. Continued acquisitions of upland properties and waterlot leases as they become available will ensure the ongoing development of a key recreational resource on Burrard Inlet.

"THAT municipal staff contact Mr. Tom Tsaka and Mr. William Baker to request an audible pedestrian signal be installed at the intersection of Hastings Street and Willingdon Avenue at the earliest possible date."

Council is requesting that the audible signal be installed to accommodate the residents of Confederation House.

Councillor Young advised that he has also received a request for the relocation of postal boxes at the intersection of Reigate Road, Welsley Drive and Sixth Street. The post box is currently on a road right-of-way which causes traffic congestion at the three way stop.

### Councillor Rankin

Councillor Rankin advised that the Globe and Mail recently reported that the President of the Federation of Canadian Municipalities has made a submission to the Parliamentary Committee reviewing amendments to Bill C-86, legislation which affects the Immigration Act. Councillor Rankin is concerned that comments made on behalf of municipalities by the F.C.M. may not reflect the attitude of municipalities across Canada. Councillor Rankin is concerned that the F.C.M. has not received input from municipalities across Canada before putting forward a position on their behalf. Councillor Rankin would like future discussion with Council as to how the Federation of Canadian Municipalities receives input from its members on critical issues where no policy exists. Councillor Rankin will provide further information in regard to this subject matter to Council members at a future date.
