RECOMMENDATION

1. THAT this report be received for information purposes.


REPORT

On 1992 January 27, Council asked staff to provide information on the preparation of a resolution for submission to the 1992 Union of B.C. Municipalities' Convention requesting authority under the Municipal Act to regulate the hours of operation of pool halls. This request arose from Council's discussion of municipal authority to control pool hall hours of operation. At that time, we advised that the authority to control pool hall hours under the Municipal Act was uncertain.

In following up on Council's request, we discussed this issue with the U.B.C.M., the Ministry of Municipal Affairs, Recreation & Housing, and most of our neighbouring municipalities. We found that all of the municipalities with pool halls regulate their hours of operation. (See Attachment 1).

Based on this review, we have concluded that a resolution to the U.B.C.M. is not necessary.

With regard to whether or not Burnaby should enact a bylaw to control the hours of operation of pool halls, the Planning & Building Department is currently preparing a report on the regulation of places of amusement, including pool halls. This will be presented to Council in the next two or three months.
