1. Housing Committee

Re: Non-Market Housing Component for George Derby Lands

The Housing Committee submitted a report pertaining to the provision of the non-market housing component of the George Derby development. CMHC has advised that it intends to meet Burnaby's policy of requiring 20% non-market units through the combination of a traditional non-profit rental project and a modest cost homeownership demonstration project. The Housing Committee is concerned that under the modest homeownership program, the income levels of the target households are higher than could be reasonably considered "affordable." The Committee would like to see more innovative programs examined, such as the equity cooperative option as an alternative to the affordable homeownership proposal.

The Housing Committee recommended:

- 1. THAT Council accept the proposal to develop one half of the units reserved for non-market housing on the George Derby site under the Non-Profit Rental Housing Program, subject to a satisfactory agreement being reach by CMHC and the B.C. Housing Management Commission/Provincial Rental Housing Corporation.
- 2. THAT Council not accept the proposal to develop the other half of the units using the proposed modest homeownership demonstration project, but recommend the CMHC try this approach on another development enclave.
- 3. THAT Council recommend that the equity co-operative housing option be investigated further, and the details of such an approach be reported back to the Committee.

2. 1993 Business Licence Fees

The City Manager submitted a report from the Director Finance outlining amendments to the business licence fee structure and various components of the Business Licence Bylaw for 1993. A two percent infiationary increase is proposed for most new and some renewal licence categories where the cost of licensing exceed the current fees. The report also proposes changes to the Business Licence Bylaw which would prohibit the door-to-door solicitation of security services and permit office administration type businesses to relocate within the same bullding at no additional charge above regular fees. The report also proposes adjusting home base business licence fees to establish a more equitable and cost conscious approach; increasing the hotel pub licence fees equal to that of neighbourhood pubs; increasing cabaret licence fees to the \$3,000 maximum in 1993; raising arcade and pool hall licence fees to the \$3.000 maximum over four years and improving non-resident contractor licence renewal procedures.

The City Manager recommended:

- 1. THAT the following bylaws be amended to provide for the fees outlined in the attached Scheduled A to E, effective 1992 January 01:
 - a) Burnaby Business Licence Bylaw No. 3089
 - b) Burnaby Cab and Commercial Vehicle Bylaw No. 3102

 - d) Burnaby Ciub Regulation Bylaw No. 3065
 - e) Burnaby Automatic Vending Machine Bylaw No. 1914; and
- THAT Burnaby Business Licence Bylaw No. 3089 be amended to prohibit the door to door solicitation of security services; and
- 3. THAT Burnaby Business Licence Bylaw No. 3089 be amended to permit businesses that function as an administration office to relocate within the same building at no charge above the normal licence fees; and
- 4. THAT Burnaby Business Licence Bylaw No. 3089 be amended to clarify that non-resident businesses are required to be ilcenced; and
- 5. THAT Burnaby Business Licence Bylaw No. 3089 be amended to more reasonably administer licence renewals to non-resident contractors.

The report summarizes the approach by the City to the provision of suitable landscaped development sites and the protection of desirable existing vegetation in Burnaby. The report outlines existing procedures and guidelines including refinements arising out of the current study and also suggests areas where further initiatives will continue to be pursued. These guidelines are intended as a useful reference for the handling of existing vegetation/trees on City lands.

The report also provides a basis for discussion of the recently passed Bill 77 which provides municipalities with the ability to protect existing trees and vegetation, including stronger enforcement powers.

Although redevelopment in this area will not occur until after 1993 July 31, the owners indicate that the buildings are deteriorating rapidly and they are concerned that these buildings pose a safety and fire risk. As the dwellings are not suitable for occupancy, and as upgrading would not be appropriate given the re-development objectives for the area, they wish to proceed with demolition. Planning Department staff advise that the dwelling at 6450 Arbroath Street is listed on the City's preliminary heritage inventory and has been identified as a craftsman-styled house circa 1912. As a result, staff are recommending that this building not be demolished until an appropriate plan for its use can be developed.
