In conclusion, Mrs. Hillstrom submitted a petition containing some 1,300 signatures of area residents, people who work in the area and people who frequent the local businesses. The content of the petition reads as follows:

"We, the undersigned request Burnaby Council to have all of the trees at the intersection of Edmonds and Canada Way; 11 Chestnut trees along Canada Way and 19 Maples along Edmonds Street, dedicated heritage trees and insure their preseveration for future generations."

The speaker also submitted letters from Edmonds Elementary School students. Both the petition and the letters are on file in the Municipal Clerk's Office.

The relocation of the Burnaby Chamber of Commerce from 6525 Sprott Street has made continued use of that facility not feasible for 1992. The Chamber has also stated that it would need to operate any temporary facility with volunteers if it were requested to continue the fee-for-service contract for 1992. The Burnaby Tourism Development Strategy will be prepared and submitted to Council during 1992 which will outline a recommended course of action in relation to Tourist InfoCentres in the Municipality that may well suggest a refocusing towards a more Burnaby oriented clientele.

A Central Valley Tourist InfoCentre does provide a valuable regional service in giving freeway oriented visitors to major destination points in the region; however, the Chamber has indicated that although there is an attempt to direct visitors to Burnaby facilities, the large majority of visitors use the facility as a "first stop" facility seeking information on the Greater Vancouver and surrounding areas. Staff are of the opinion that, given the highly regional context for a Central Valley InfoCentre, one could argue that Municipal financial support for tourism should be directed more towards promoting Burnaby based facilities rather than regional ones.

Considering this, in combination with the fact that the Chamber would need to utilize volunteers to operate the temporary InfoCentre with no guarantee on the level of service provided, staff are of the view that Municipality should not enter into a fee-for-service contract for 1992.

The Acting Municipal Manager recommended:

- 1. THAT the Municipality not enter into a fee-for-service contract with the Burnaby Chamber of Commerce to operate a Tourist InfoCentre during 1992.

The Acting Municipal Manager submitted a report from the Director Planning & Building providing staff comment on the letter received from Ms. Sue Kiernan requesting an extension of the sublease of the municipal property at 4503 Inman Avenue for use by the Maples Adolescent Treatment Centre. The report provided details on the background on lease and sublease arrangements, and the Elizabeth Fry Society's request for further extension of sublease arrangements.

Staff indicate that the Municipality has a record of supporting de-institutionalization policies and facilitating community-based living opportunities for people with special needs. This has been demonstrated by the fact that the Municipality has leased land to non-profit groups for development of group homes and has also been shown in Council's decision to authorize staff to consult with Provincial ministry officials and others in an effort to identify policies and protocols to assist with the future planning and development of group homes in Burnaby.

Undertaking a trade mission of this nature is also consistent with the Municipal Economic Development Strategy.
