Re: Request endorsement of resolution regarding Canadian <u>Arms Export to Mideast</u>

A letter dated 1992 March 30 was received from the City Cierk, City of Vancouver advising that Vancouver City Council adopted the recommendations of its Special Advisory Committee on Peace with regard to Canadian arms exports to the Middle East.

Vancouver City Council is requesting Burnaby Council also endorse the recommendations of the Special Advisory Committee on Peace.

Canadian Arms Export to the Middle East

WHEREAS constraining the production and deployment of conventional weapons is essential to preventing the escalation of regional wars into wider conflicts involving the use of weapons of mass destruction, and thereby threatening the welfare of citizens of every municipality;

AND WHEREAS Canada's laws and regulations have heretofore forbidden the sale and export of weapons to countries involved in active or imminent armed conflict, or the countries which are notorious violators of human rights or countries which employ arms to oppress their own citizens;

AND WHEREAS Prime Minister Mulroney has called upon leaders of the world community to implement measures that would help to contract the international traffic in conventional weapons;

AND WHEREAS contrary to these praiseworthy declarations and inconsistent with its foreign policy and export guidelines, the Government of Canada has recently amended the Criminal Code by Bill C-6 to permit the export of automatic rifles, and to increase Canadian participation in the international arms traffic by allowing the sale of 1,117 light-armoured vehicles to Saudi Arabia, a nation which violates the human rights of its citizens and which is also involved in or under imminent threat of hostilities with its neighbours;

THEREFORE BE ITS RESOLVED THAT the Special Advisory Committee on Peace urge the Federal Government (1) to repeal Bill C-6, (2) to intensify instead its efforts to prevent the proliferation of armaments by initiating and supporting measures intended to decrease, not increase, the global arms trade, (3) to preserve the jobs of Canadian workers by encouraging those enterprises which are engaged in arms production to convert that portion of their capacity which exceeds domestic security needs to the manufacture of goods for civilian use, and (4) to ensure that any further proposals intended to permit the export of weapons produced in Canada be preceded by comprehensive hearings by Parliamentary Committee so that Canadians may express their opposition to this practice;

AND FURTHER BE IT RESOLVED THAT the Special Advisory Committee on Peace communicate these concerns to all other Canadian municipalities to solicit their support.

- Excessive soii, gravei and dust on the roadway has been swept and flushed on a regular basis and cleaning is being conducted at the end of each working day; and
- Municipal staff and Stride Elementary School staff have met with the road contractor to discuss ways to minimize disruption to students and to establish a safe pedestrian route adjacent to Stride Elementary School.
