Ms. Edwards advised that nine moths have been found in an area near the Cariboo RV Park. Egg mass searches to date have not located any masses, however, the search will continue. Agriculture Canada have made application to spray Foray 48B BTK to eradicate this pest. The application covers an area of 236 hectares and will allow spraying for a three year period. Although Agriculture Canada do not intend to spray continually for that time frame, this allows an opportunity to pursue the problem should it arise in the future.

Councillor Corrigan retired from the Council Chamber at 7:30 p.m.

 Ms. Lorna J. Hancock, Executive Director, and Mrs. Theima McAdam, Chair, Environmental Committee, Health Action Network Society appeared before Council to address an application by Tycor Technology Ltd. to operate a hazardous waste incinerator in Burnaby.

Councillor Corrigan returned to the Council Chamber at 7:40 p.m. and took his place at the Council table.

The speaker requested answers to the following questions with respect to development of the incinerator:

- 1. What will be burned?
- 2. Where does the waste come from?
- 3. What is the chemical composition of the waste?
- 4. What will be the temperature at which the incinerator will operate?
- 5. How long will the gases be exposed to the flame?
- 6. What type of scrubbers will be used?
- 7. What type of filter will be used?
- 8. Will the filter be cleaned regularly?
- 9. How will the filter residue be disposed of?
- 10. Where will the fly ash and bottom ash be disposed of?
- 11. Will they use wet scrubbers?

- 12. If so, where will the water be disposed of?
- 13. Will the waste be treated?
- 14. How hot will the gases be before they hit the water?
- 15. What method of cooling will be used?
- 16. What volume of material will be burned?
- 17. Will the waste be segregated?
- 18. What is the speed of gas as it leaves the stack?
- 19. What will happen to derivatives of benzene created during burning?
- 20. Who will monitor the program?
- 21. Who will conduct inspections?
- 22. Who will test emissions?
- 23. Will the monitoring be made public?

The speaker concluded by suggesting the minutes of a meeting which took place in Seattle and was attended by representatives from Agriculture Canada with respect to the European Gypsy Moth be obtained by the City for Information.

Arising from the discussion Council requested staff obtain minutes of the Seattle meeting.

3. Liz Craik and Robert Joida, Association of Reptile Keepers of B.C., appeared before Council to express opposition to a proposed animal control amendment bylaw which limits the keeping of reptiles to two snakes and four rodents per household.

The speakers felt that the bylaw should restrict the manner in which the animals are kept, not the number of animals. Concerns were expressed with respect to limitations placed on captive breeding operations by limiting the number of snakes allowed. In addition, the speakers were concerned that limiting the number of rodents may inhibit the ability of pet owners to feed their reptiles. Ms. Craik recommended the reptiles be kept in locked, secure cages to avoid problems with escape.

Staff advised that the existing irrigation system has deteriorated to the point where it leaks constantly and suffers almost daily breaks during heavy use. As a result, significant quantities of water are wasted and staff are unable to adequately water the tees, greens and fairways. A new automatic system would make efficient use of the water and ensure the course quality is maintained and golf revenues are maintained or increased.

The City Manager recommended:

1. THAT a Capital Reserves Bylaw in the amount of \$624,000 be brought forward to finance the replacement of the irrigation system in Burnaby Mountain Golf Course.

In concert with this, the new G.V.R.D. Air Pollution Bylaw has undergone a public review and is in the final stages of implementation.



 - i) The retention of as many existing mature trees as possible on the site.

- m) The deposit of the applicable per unit Neighbourhood Parkland Acquisition Charge.
- n) The granting of a 215 Covenant restricting enclosure of balconies.
