Issues to be considered include the substantial cost involved which would probably exceed \$20 million and the likelihood that, if a directive were issued through the B.C. Utilities Commission to bury these lines, other communities would want the existing transmission lines in their areas to be placed underground as well. This could conceivably create a potential cost of hundreds of millions of dollars for B.C. Hydro's rate payers.

A staff notation appended to this item of correspondence advises that staff are in the process of reviewing this letter with the City of Vancouver. A staff report will be submitted to Council as soon as an appropriate approach can be coordinated with the City of Vancouver staff.

 West Coast Environmental Law Research Foundation, 1992 September 10, Re: Using Conservation Covenants to preserve Private Lands in B.C.

> A letter dated 1992 September 10 was received from the West Coast Environmental Law Research Foundation regarding the use of conservation covenants to preserve private land in B.C. The writer provided a copy of a report entitled "Using Conservation Covenants to Preserve Private Lands in British Columbia" and requested comments on same. The Real Estate Foundation of British Columbia funded the research for this publication in order to catalyze discussion about how conservation covenants could be used effectively in British Columbia for the voluntary preservation of private land.

> A staff notation appended to this item of correspondence advises that existing Provincial legislation allows granting of covenants (including environmental covenants) in favour of government bodies for a variety of purposes. This approach is considered inadequate for addressing the broad range of ecological reasons for protecting land in B.C. The report recommends that British Columbia enact legislation that would allow landowners to achieve voluntary protection and preservation of private iands through the granting of conservation covenants to private organizations. The report describes the existing situation, makes specific recommendations for law reform, and outlines tax implications. A two page Executive Summary has been attached to this letter.

> Unless Council directs to the contrary, staff will submit a report to the Environment and Waste Management Committee in the near future.

Staff agree that flag provisions for Canadian, Provincial and new Burnaby flag are desirable and would enhance Civic Square. An appropriate installation and location would be a grouping of three flagpoles symmetrically located with respect to the Civic Square, along the Central Boulevard frontage just behind the bronze plaque unveiled by the Governor General in officially opening Civic Square.


