9. Street Lighting - 4400 Victory Street

The City Manager submitted a report from the Director Engineering prepared in response to Mr. Peter Hanson's request for adequate street lighting in the 4400 block of Victory Street.

Staff advised that Council's policy regarding the placement of interim lighting requires the installation of lighting at intersections and mid-block if the distance between intersections exceeds 213 metres. The Intersection of Victory and Sussex is lit by the City owned lighting on Sussex Avenue and the intersection of Victory and Dow is lit by City owned lighting on Dow Avenue. The distance between the intersections is less than 140 metres. Therefore, in this case, the conditions of the interim lighting policy have been satisfied.

Staff concluded by advising that Mr. Hanson has been sent an information letter regarding the installation of lighting to a finished standard under the Local Improvement Program.

Ms. Redman further advised that a number of new library services were introduced in 1992 including the English as a second language collection at the Kingsway branch and direct public access to CD-ROM Data Bases at the Bob Prittie Metrotown Branch. The speaker concluded by advising that these successes are the result of Council's ongoing support for library operations and the dedication of library staff.

6. Letter from Mr. Jack Beecroft 6992 Dunblane Avenue

The City Manager submitted a report from the Acting Director Planning and Bullding prepared in response to a letter from Mr. Beecroft, 6992 Dunblane Avenue, requesting that further consideration be given to subdivision of his property into two 33' x 155' lots.

Staff advised that Mr. Beecroft's property is located in the R5 District, which has a provision for subdivision into small lots of the width desired when at least 30 percent of the existing lots in the block front have widths of 45 feet or less.

In this case, only two lots of 13 in the block front meet this criteria (15 percent), and hence the owner has been informed that the lot does not have subdivision potential under the established bylaw.

Staff concluded by advising that during the course of public consultation in connection with the first phase of the residential growth management study work in late 1992, interest was expressed by some citizens in exploring ways of allowing infilling or increases in density in certain areas in Burnaby. It is intended that further exploration of the possibilities will take place in upcoming phases of the growth management work. It would be appropriate for the interest in permitting small lots subdivision in the Dunblane area to be considered in that context, with opportunities for public input.

Council's desire to house seniors on the Oakalla site has been partially satisfied by 15 Phase 1 units (20 percent of Phase 1 units). Future phases do afford further opportunities for providing additional non-market options for seniors. Staff further advised that they propose to continue working with B.C.B.C. to investigate such options and to keep Council apprised of progress.

The Housing Committee recommended:
