CARRIED UNANIMOUSLY

a) Mr. P.J. Doyle, Vice President Finance, Canlan Investment Corporation, and Mr. Brian Bartlett, General Manager of Four Rinks complex appeared before Council to discuss the staff report prepared in response to the proposed Four Rinks expansion. Mr. Doyle advised that he would be addressing two primary concerns; the retention of a 40 ft. strip of land east of Four Rinks for future public use and the potential impact of the Four Rinks Proposal on existing Poplar trees.

The speaker advised that it seems more appropriate to use the small segment of the site requested by Four Rinks to meet an urgent, recreational need of the public in the present than to reserve the site for unspecified use, public or private in the future. In addition, the speaker advised that it may well be that the poplar trees do not have to be removed to create the parking. The more obvious solution would be to replace the low value poplar trees, if they have to be removed, with evergreens which will provide all season screening. A further solution would be to provide Four Rinks with the additional parking on municipal land to the north rather than to the east of Four Rinks. Mr. Doyle, in providing a review of the economic considerations in deciding whether Burnaby should develop a single rink, or have Four Rinks develop a new four rink complex, advised that over a five year period the municipality will save between \$9,000,000 and \$10,000,000, if it allows Four Rinks to proceed with its expansion. The speaker provided a summary of cost savings over five years, if Four Rinks develops a four rink complex.

Councillor Drummond entered the Council Chamber at 7:15 p.m. and took his place at the Council table.

Councillor Corrigan entered the Council Chamber at 7:15 p.m. and took his place at the Council table.

Council requested staff provide Mr. Doyle with the most recent staff report on this subject for his perusal.

b) Mr. Doug Porter, 7382 Thurston Street, Burnaby appeared before Council to express his concerns regarding onsite activities on property prior to completion of the rezoning bylaw process. The speaker stated that errors can occur resulting from situations such as engineering or architectural drawings not being approved, the drawings could be incomplete or incorrect and could be changed prior to being approved. The current level of tree protection during the rezoning process is not adequate and there is no legal protection until the rezoning bylaw is adopted. The speaker suggested that the City exercise caution in allowing onsite work to proceed until the rezoning process is completed. The speaker suggested that a penalty of a minimum of \$10,000 per protected tree, if cut down, would make those responsible very careful about how they treated vegetation.

The speaker proposed that a moratorium be placed on all regulated tree cutting until the Tree Protection Bylaw is adopted. Mr. Porter requested Burnaby investigate ways to make the rezoning process more accessible to public participation.

Councillor Corrigan retired from the Council Chamber at 7:35 p.m.

Councillor Evans retired from the Council Chamber at 7:37 p.m.

c) Thelma MacAdam appeared before Council on behalf of the Health Action Network Society to discuss plans for future disinfection of the water supply of the Lower Mainland.

Councillor Evans returned to the Council Chamber at 7:40 p.m. and took his place at the Council table.

Councillor Redman retired from the Council Chamber at 7:40 p.m.

Councillor Corrigan returned to the Council Chamber at 7:42 p.m. and took his place at the Council table.

The speaker requested that Council further investigate all options regarding secondary disinfection. Thelma MacAdam advised that she had received a consultants' report wherein it was stressed that there is another option available and that is, OX Ozone which is considered to be a much safer form of secondary disinfection and is currently used in some European countries. The report highlighted OX Ozone as being the most favoured due to cost factors being less, low maintenance, viruses are controlled and the water can be used in kidney dialysis. The speaker advised that she is receiving substantial literature from the United States on the harmful effects of chlorine.

Councillor Redman returned to the Council Chamber at 7:43 p.m. and took her place at the Council table.

The speaker congratulated Burnaby as being the only municipality who is examining the affects of the options available for secondary disinfection in water treatment.

His Worship, Mayor W.J. Copeland advised the delegation that there is a Secondary Disinfection report on the regular Council agenda which will be dealt with in the regular order of Council business.

d) Mr. Phil Moore, Remax Realty, 4603 Kingsway appeared before Council to address Item 18, Managers Report No. 44 and to express his appreciation that the report was now before Council. The speaker advised that on December 7, 1992 he was appointed as the agent for the owner of the properties at 3785, 3792 and 3797 Nithsdale Street and made application for the tentative enclosure and relocation of the water course.

> The City Manager submitted a report from the Director Planning and Building providing information on introduced legislation intended to give local governments new powers to increase the supply of affordable housing. Staff advise that Bill 57 is intended to accomplish two purposes: Firstly, it allows the Lieutenant Governor in Council (Cabinet) to grant specified additional powers to local governments. Through this, it can respond to specific needs, particularly in relation to the provision of affordable and special needs housing in municipalities. It also replaces some enabling aspects of the Municipalities Enabling and Validating Acts. Secondly, it provides more specific authority for municipalities to do the following:

- establish in their zoning bylaws increased permissible densities in exchange for specified amenities or affordable or special needs housing.
- . designate in their zoning bylaws for affordable or special needs housing, subject to the consent of the property owners affected, and
- . enter into agreements with property owners to ensure the development and continued availability of affordable and special needs housing.

Staff advise that this legislation will allow the City to continue to seek innovative partnerships with the private sector and other government agencies to ensure that a balanced range of housing opportunities are provided in Burnaby. The City Manager recommended:

- 1. THAT a letter be forwarded to the Minister of Municipal Affairs, Recreations and Housing indicating the City of Burnaby's support for Bill 57 as a positive step in assisting local governments in their combined efforts to facilitate more affordable and special needs housing.
- 2. THAT a copy of this report be forwarded to the Housing Committee as part of its deliberations on the provision of affordable housing in the City of Burnaby.

> The City Manager submitted a report from the director of Planning and Building to obtain council endorsation of a process involving public consultation and leading to the establishment of a revised Brentwood Town Centre Development Plan and to obtain authority to make application for a 1993 Planning Grant. The report outlines a phased process towards the eventual establishment of a revised Brentwood Town Centre Development Plan with significiant opportunities for the public consultation. This input will assist a determine a comprehensive policy framework, leading to a revised Brentwood Town Centre Development Plan. It is proposed that a Planning Grant Application be made to the Province to assist the City in carring out this review which would result in an amendment to the official Community Plan.

The City Manager recommended:

1. THAT staff be authorized to initiate a public consultation process related to the review of the Brentwood Town Centre as outlined in this report and summarized on Appendix a leading to a revised development plan for eventual inclusion within the Official Community Plan. 2. THAT Council authorize an application under the 1993 Planning Grant Program to support the City's planning initiatives associated with the development of a revised Brentwood Town Centre Development Plan.

Councillor Nikolai informed the members of Council that the project to discourage prostitutes from remaining in the Kingsway corridor, in conjunction with the R.C.M.P. and a group of concerned residents, has been successful due to the fact that the neighbours worked with the police to resolve the problem. The project ran from 1993 June 09 to June 26. Coverage was provided by the R.C.M.P. every day from 1:00 p.m. until 4:00 a.m. the following morning. All prostitutes checked by police were advised that street prostitution would not be tolerated and whatever legal action was required to have it cease would be taken. Most of the prostitutes checked during this operation have moved back to the Vancouver and Surrey areas. Councillor Nikolai provided statistics that directly related to the enforcement undertaken during this project.
