IMPROVEMENTS

PURPOSE:

To obtain approval to award a contract for the widening of

Imperial Street at and east of Boundary Road.

RECOMMENDATION:

1. THAT a contract be awarded to the lowest bidder, Jack Cewe Ltd., for the widening of Imperial Street at and east of Boundary Road for a total cost of \$253,861.00 with final payment based on actual quantities and unit prices tendered.

REPORT

Four tenders for this work were received by the closing time of 3:00 p.m. Tuesday, 1993 September 7 and were opened by staff in the presence of representatives of the firms bidding. A tabulation of the tenders received is attached (Attachment A).

The work of this contract involves the supply of all labour, materials and equipment required for the widening of Imperial Street at and east of Boundary Road, to accommodate separate left and right turn lanes.

The Director Engineering's estimate for this work is \$275,200.

The recommended bidder, Jack Cewe Ltd., has been in business in the lower mainland for approximately 37 years. In addition to the numerous works previously completed for the City, Jack Cewe Ltd. is presently performing work for the City under Contract 9302 - Local Improvement Paving, Contract 9304 - Griffiths Connector Phase 2, Contract 9313 - Machinelaid Asphalt, Contract 9308 - Gravel Supply and Contract 9317 - Road Reconstruction. Based on their past performance, the Director Engineering is satisfied that they have the necessary experience and resources to complete the work of this contract.

This project is included in the 1993 Capital Budget under Major Roads. Capital Works Expenditure Bylaw No. 9955 which provides funding for this work was approved by Council on 1993 September 7.

The Director Engineering and our consultant, R.F. Binnie & Associates Ltd., concur with the above recommendation.
