#### CARRIED UNANIMOUSLY

 a) Christine Gilmour, 319 Marmount Street, Coquitlam, B.C. and Sadie Baggen-Mueller, 1093 Marine Drive, West Vancouver, B.C. appeared before Council to discuss problems encountered in the transferance of stalls from the Burnaby Horseman's Association to the two speakers. Ms. Gilmour provided Council with a copy of the Burnaby Horseman's Association's rules and regulations pertaining to the transferrance of stalls. The speaker stated that both parties have complied with all the rules and regulations as stated but that the ownership of stalls has not been transferred.

Ms. Baggen-Mueller then addressed Council providing a chronology of events surrounding the proposal to transfer stall ownership.

The two stalls in question were licenced by Mrs. Mildred Dawe. Mrs. Dawe advised the Burnaby Horseman's Association of her desire to relinquish her licences. In accordance with Burnaby Horseman's Association rules and regulations, the Association has the right of first refusal on stall licences. If the Association does not exercise its right within 30 days of notification, the stall licence holder has the ability to sell the licences privately to members in good standing of the Association.

The Horseman's Association did not exercise its right within the 30 as notified by Mrs. Dawe and as a result Mrs. Dawe offered the licences to Ms. Gilmour and Ms. Baggen-Mueller. The Association is now refusing to approve transfer of the licences because their failure to initiate their option on the licences was an oversight. The speakers are requesting Council's assistance in resolving the dispute with the Burnaby's Horseman's Association.

A staff notation appended to the delegations' request to appear before Council advises that Christine Gilmour and Sadie Baggen-Mueller appeared as a delegation and spoke on the same subject at the Parks and Recreation Commission meeting held on 1993 February 03.

The Parks and Recreation Commission has requested staff prepare a report on this situation for further review.

Council has been provided with a copy of the material that the delegation submitted to the Commission on 1993 February 03, under separate cover.

b) Mrs. Mildred Dawe, 27968 - 112th Avenue, Maple Ridge, B.C. appeared before Council to discuss the disposition of stalls between herself, the Burnaby Horseman's Association, Christine Gilmour and Sadie Baggen-Mueller.

Mrs. Dawe outlined her actions with respect to the transference of stall licences and advised that she first gave notice to the Burnaby Horseman's Association on 1992 November 26. Mrs. Dawe received no further contact from the Burnaby Horseman's Association and when the 30 day period expired, she offered the stalls to Christine Gilmour and Sadie Baggen-Mueller, who paid the appropriate fees.

The ownership of the stalls is now in dispute as the Burnaby Horseman's Association is claiming their right to the licence while Mrs. Dawe has sold the stalls to Ms. Gilmour and Ms. Baggen-Mueller.

Council requested that a copy of the staff report be provided to Council following its submission to the Parks and Recreation Commission.

The spraying would be completed between dawn and 7:30 a.m. and would take only minutes to complete. Agriculture Canada has determined that this method would be the most successful for eradication; be less disturbing to homeowners than a ground spray program and be more cost effective.

# a) Environment and Waste Management Committee Re: Proposed Changes to existing Deposit-Refund Legislation

The Environment and Waste Management Committee submitted a report prepared in response to proposed changes to existing deposit-refund legislation and beverage container strategies. The Provincial government is currently reviewing two proposals, one in support of refillable beverage containers and the second in support of an expanded blue box beverage container recovery program. In view of Burnaby's current support of 3R waste management, being reduce, reduce the recycle, it would be appropriate for the City to express support for a refillable container system as being more environmentally responsible than recycling.
