The speaker reviewed an independent study of fair wage policies entitled "Analysis of Fair Wage Policies in B.C. and other Jurisdictions". The study was completed by three professors from Simon Fraser University and U.B.C. which notes that fair wage policies increase costs to taxpayers by 6 to 7% and that Burnaby's rates are 15% higher than those established by the Provincial fair wage policy. Mr. Hochstein noted that the report concludes that taxpayers are the unambiguous losers of B.C.'s fair wage policy. Councillor Redman retired from the Council Chamber at 8:12 p.m.

Mr. Hochstein concluded by circulating a copy of the fair wage study and requesting Council cancel Burnaby's fair wage policy or suspend the policy until Council can commission its own independent review.
