Re: Village of Belcarra's Resolution on the Young Offenders Act

RECOMMENDATION:

1. THAT Council support the Village of Belcarra's resolution concerning the Young Offenders' Act of Canada.

REPORT

Council, at the regular Council meeting held on 1993 January 04, received correspondence from the Village of Belcarra requesting support of a resolution for review of the Young Offenders' Act. Council subsequently referred this correspondence to the Family Court and Youth Justice Committee for review.

At the Family Court and Youth Justice Committee meeting held on 1993 January 06, the Committee discussed the Village of Belcarra's request for support of its resolution (Attachment I) for review of the Young Offenders' Act and recommend that Burnaby Council also support the resolution.

Your Committee further suggests that the Village of Belcarra pursue a request to the Minister of Justice to review the overall problem of youth violence in order to provide adequate treatment or preventative facilities in addition to the legislative services.

Recently, there has been considerable media attention surrounding an apparent rise in youth oriented crime in British Columbia. The actions of young offenders do not appear to receive the same focus of the courts as those committed by adults.

The municipal Council for the Village of Belcarra believes that, although most of us cannot stop the crime committed in our society, we can perhaps address the matter of the legislation which permits some members of society to avoid prosecution. As a result, Belcarra Council has passed a Resolution (attached) which encourages the Solicitor General of Canada to review the "Young Offenders Act" with a view to introducing amendments to better protect our society.

AND WHEREAS young offenders in Canada appear to enjoy an extraordinary status under this Act which may not achieve the appropriate balance between the rights of young offenders and those of society as a whole;

SCHEDULE " A"

REVISION OF THE YOUNG OFFENDERS ACT

The following concerns are suggested areas which may be further investigated during a review of the Young Offenders Act.

While the Act appears to adequately serve the needs of first-time offenders, many Canadians are worried that it does not provide satisfactory protection to the public against the criminal actions of chronic or repeat offenders. As a result, the Village of Belcarra urges the Federal Government to undertake a revision of the Young Offenders Act, so that it will adequately protect the public from the criminal actions of young offenders.

While the Young Offenders Act seems to recognize the importance of public protection in Canada, we would draw your attention to the following excerpt:

Section 3 (1) (b):

"Society must, although it has the responsibility to take reasonable measures to prevent criminal conduct by young persons, be afforded the necessary protection from illegal behaviour;"

It would appear there is little in the Act that will afford protection from illegal behaviour of the young offenders. Specifically, the following areas might be considered as a guide to concerns currently held by the general public:

- a) Adequate protection of the general public from the young offender.
- b) A viable way to protect and assist law enforcement officers as they attempt to enforce the Act.
- c) The protection of under-age people, who may be directly influenced by a criminal element, or who may be acting as a result of peer pressure. These individuals would not normally commit a crime, however, neither are they adequately protected under the Act.
- d) Review of the "rehabilitation "program for young offenders, with a view of providing recommendations to improve existing guidelines.
