PURPOSE:

TO SEEK COUNCIL AUTHORITY TO ENTER INTO AN AGREEMENT WITH THE PROVINCE OF BRITISH COLUMBIA FOR A \$346,260.00 GRANT TO BUILD A CHILDCARE CENTRE

AT 6786 SOUTHPOINT DRIVE, BURNABY

RECOMMENDATION:

1. THAT Council authorize the execution of an agreement with the Province of British Columbia for a \$346,260.00 grant to assist in the construction and set-up of a childcare centre at 6786 Southpoint Drive, Burnaby.

REPORT

The lands at 6786 Southpoint Drive were transferred to the City of Burnaby by B.C. Hydro as part of the development approval for the adjacent B.C. Hydro headquarters lands and for the purpose of establishing a childcare centre. B.C. Hydro also provided Burnaby with a \$250,000 payment toward the cost of building a childcare centre on the lands.

The Province of British Columbia has now agreed to provide Burnaby with a grant of \$346,260.00 (or 50% of project costs for establishing the childcare centre, whichever is less) under the Ministry of Women's Equality, Child Care Branch, Facilities and Equipment Grant Program. According to information received from the Province this is the largest single grant which has been made under this program to date (see Attachment 1).

The Province requires Burnaby to execute an agreement (copy available in City Solicitor's office) in order to receive the grant. The main purpose of the agreement is to ensure that the grant funds go towards the cost of establishing the childcare centre. The agreement would require Burnaby to repay the grant if Burnaby ceased to use the lands as a childcare centre within ten years from the date of completion of the childcare centre.

The Provincial grant will provide substantial assistance in the building and establishment of the childcare centre. The terms of the grant agreement are reasonable. It is therefore recommended that the grant be accepted on the terms set out in the agreement.

FUNDING FOR CHILD CARE TO CREATE MORE SPACES PROVINCE-WIDE

VICTORIA — About 1,400 licensed child care spaces will be created and upgraded throughout British Columbia with the help of more than \$1.6 million in provincial government grants, Women's Equality Minister Penny Priddy announced today.

Priddy said her ministry will provide dollars through its Facilities and Equipment Grants program, with funds going to 34 projects to help pay for purchase of land, buildings, facilities, equipment and furniture.

"This grant program is one step in our government's commitment to working with communities, and giving them the resources to provide safer and more accessible care for their children," Priddy said.

"A new centre that meets the particular child care needs of a community is more than just new spaces," said Priddy. "It's a safe and caring place for children whose parents work outside the home."

"In these tough economic times, that kind of support is essential to help parents manage demanding work schedules. It will also strengthen the growth and development of our economy by creating work in the construction industry and new jobs in the child care field."

Child care is an important factor in the growth of a skilled labour force — mothers with children under 12 currently make up 62 per cent of the female workforce. Child care directly provides about 15,000 paid full-time jobs in British Columbia, and indirectly creates another 3,000.

MINISTRY OF WOMEN'S EQUALITY FACILITIES AND EQUIPMENT GRANTS AWARDED BACKGROUNDER

In April 1992, the government of British Columbia announced a \$17 million child care plan for 1992/93. The new Facililes and Equipment Grant program is part of a larger strategy to expand child care in British Columbia, focusing on the most under-served areas such as school-age and infant/toddler care, and care which supports flexible work hours.

Facilities and Equipment Grants are available to non-profit societies, regional districts and municipalities to create licensed child care spaces. Funding is available for up to 50% of eligible capital costs to a maximum total grant of \$500,000. Dollars are eligible for:

land or facility acquisition;

construction or renovation of an existing facility; and

purchase of furnishings and equipment.

Since the program's implementation in September 1992, over \$2 million has been approved for child care projects across the province.
