1. MINUTES

Dr. King and Mr. Shum answered questions from Council and Dr. King provided the following summary:

- 1. Two deaths due to Legionella pneumophila pneumonia in the same household in Burnaby have been confirmed.
- 2. A recently installed hot tub with inadequate disinfection has cultured positive for the organism and is the probable source of infection for the cases.

a) Mrs. Diana Mumford, 3955 Southwood Street, Burnaby appeared before Council and on behalf of parents and residents of the South Slope area wished to thank Council and the Traffic and Transportation Committee for their efforts in addressing the issue of traffic safety around elementary schools.

In addressing the report of the Traffic and Transportation Committee on this matter the speaker felt that there were still some concerns outstanding on this issue. In Mrs. Mumford's opinion, improved education for automobile drivers is required to increase awareness of children using busy urban streets. The speaker also wished to draw Council's attention to the idea that dangers presented to young children also apply to secondary school children. In this regard the delegation requested consideration be given to posting 30 km/h signs on streets adjacent to secondary schools.

b) Ms. Jane Wace, Owner/Director of Spotlight Dance Centre, 6637 E. Hastings Street appeared before the members of Council seeking approval, notwithstanding a negative recommendation from the Director Planning and Building, to rezone property at 6631 E. Hastings from C2 Community Commercial District to C3 General Commercial District. The purpose of the rezoning is to permit the operation of her business, Spotlight Dance Centre, a self-improvement school. A self-improvement school is a permitted use in the C2 District, however, the gross floor area of her school is larger than the maximum permitted. Ms. Wace asked that Council allow her to rezone the site to the C3 District as there is no maximum gross floor area for the C3 zone.

Ms. Wace advised that Spotlight Dance Centre provides service to over 200 students, is a well established business and is an asset to the neigbourhood.

d) Mr. Mark Kosi, 7841 Meadowood Drlve, Burnaby appeared before the members of Council seeking Council's permission to retain a storage shed on his property. The storage shed had been an existing structure which Mr. Kosi wished to enclose and had done so without the benefit of a building permit. However, when the structure was inspected by a Burnaby Building Inspector, he was advised that the structure was illegal as it exceeded the permitted gross floor area for the lot.

Mr. Kosi provided Council with sketches of both the old and new storage sheds, photographs and a petition containing 15 signatures from neighbours. The text to the petition is as follows:

"Question:

As a neighbour, thus the enclosure of a storage shed at 7841 Meadowood Drive in Burnaby effect my view, my privacy or cause any nulsance whatsoever to me?" (All signatories indicated in the negative).

e) Ms. Om Sairam, 1852 Rosswood Place, Burnaby appeared before the Members of Council to protest the use by the G.V.R.D. of either chlorine or chloramine in the proposed water treatment improvements to the Greater Vancouver Water supply. The speaker advised that a questionnaire was being circulated advising that these two chemicals are being proposed; however, the average person has no idea what these chemicals are or what the affects of their use are. Ms. Sairam advised that she had heard that the United States is in the process of banning the use of chlorine and that the incident in Surrey of a fish klll, after chloramine had been spilled into a watercourse were good indications that these chemicals are not safe.

The speaker advised that in her research ozonization or super filtration systems would be better alternatives and that more research should be undertaken before selecting a treatment system for Greater Vancouver. Ms. Sairam recommended that systems used in Holland, parts of Germany, Moscow and Paris be investigated and that the City of Seattie should also be consulted as they have recently discontinued using chloramine.

In conclusion, the speaker asked that other alternatives be sought and that the time limit given by the G.V.R.D. on this matter be extended.

Councillors Corrigan and Nikolai retired from the Council Chamber at 8:30 p.m.

To ensure that the integrity of the memoriai is retained the Committee are recommending that the Cenotaph, Tennis Court and School building be designated a heritage site; that they remain together in a public park; that an interpretive plaque be placed on the site; that the park be named the "Burnaby South Memorial Park" and that a second memorial and interpretive plaque be established at the new Burnaby South site.

Between the waterfront and the stockpile is a grass buffer zone to prevent runoff into the inlet. The drainage ditch between the road and stockpile contains bales of hay to prevent sedimentation entering the inlet.

When work is completed this fall, B.A. Blacktop will scarify all the compacted area, spread topsoil and regrass the storage area to its former condition subject to Burnaby approval.

For any residential, commercial and/or industrial developments in Burnaby, the owner is required under the provisions of the Burnaby Watercourse Bylaw to Instali and maintain a sediment controi system.

Through the rezoning/subdivision process. Environmentai Heaith comments on the requirements of silt control measures. During the Preilminary Pian Approvai process of industriai, commercial or multi-family dwellings, the applicants are required to submit detailed silt control plans for the site and during construction, random site inspections are conducted by Environmental Health staff. With respect to single and/or two family residential dwellings the Environmental Health, Engineering and Pianning and Building Departments have developed the following administrative procedural improvements: an information bulletin on silt control measures is to be provided to applicants; dwellings located adjacent to creeks identified to be of importance to the B.C. Ministry of Environment. Lands and Parks and the Federai Department of Fisheries and Oceans are to have the proposed plans forwarded to Environmental Health for review and comment, and approvals are to be obtained from the aforementioned agencies.

In addition, placement of an article in the upcoming issue of Information Burnaby will further enhance public awareness regarding discharges of silt and other contaminants into watercourses.

Sierra Consultants was hired to undertake this independent review. They engaged in considerable consultation with staff in all departments to produce an updated version of the Plan.

The review confirmed our past approach was appropriate and positioned us well to take advantage of new, more cost effective technologies. The proposal involves an adjustment to changing technolgies rather than a major overhaul and its cost implications are essentially status quo.

The City Manager recommended:

It is not clear whether annexation is probable since the G.V.R.D. is only likely to support it if the watershed lands are exempt from property taxation and the municipalities are not likely to seek annexation if there is such an exemption.

Annexation would have no impact on water quality and supply which would continue to be under the control of the G.V.W.D. The City Manager recommended:

- g) Submission of a tree survey, retention of as many existing mature trees as possible on the site, submission of a written undertaking to ensure that all site areas identified for preservation of existing vegetation are effectively protected by snow fencing or other approved physical containment during the whole course of site preparation and construction work, and deposit of sufficient monies to guarantee the protection of identified vegetation to be preserved.

WHEREAS Burnaby has previously objected to the consideration of burning wastes other than municipal-type waste in the GVRD incinerator and

WHEREAS the GVRD operating policy for the incinerator is limited to burning only municipal-type waste and some olly waste with the prior approval of Burnaby Council and
