PURPOSE:

To obtain Council approval to undertake a review of accessibility in the

Metrotown area.

# **RECOMMENDATION:**

1. THAT this report be received for information purposes.

### REPORT

### 1.0 INTRODUCTION

In 1992 June, Council endorsed a proposal to undertake a review of accessibility in the Metrotown area. This proposal was included in the 1992/93 annual action plan developed by the Burnaby Access Advisory Committee.

The Burnaby Access Advisory Committee is composed of residents of Burnaby who are disabled, representatives of disabled persons' organizations and Municipal staff. The Advisory Committee assists staff in identifying barriers to services and facilities in the community, and in developing action plans to improve access for persons with disabilities.

A number of objectives regarding accessibility issues are also contained in the Metrotown Social Planning program endorsed by Council in 1992 November. Appendix 1 *attached*, lists those objectives.

This report outlines a proposal for a review of accessibility in the core business district of the Metrotown area.

### 2.0 SCOPE OF PROPOSED ACCESSIBILITY REVIEW

At its 1993 February meeting, the Burnaby Access Advisory Committee discussed the potential scope of the proposed accessibility review of Metrotown. After discussion, the Advisory Committee agreed that the scope of the accessibility review should be as follows:

Range of Disabilities: the needs of persons with disabilities affecting mobility, agility, seeing, hearing, speaking and cognitive ability should be considered in the review.

Geographical Area: the geographical area of the review should be limited to the core business district of Metrotown: the area bounded by Nelson Avenue, Willingdon Avenue, Kingsway and Imperial/Central Boulevard. Appendix 2 attached provides a map of the proposed area.

Review Elements: the review would focus on physical elements in public areas within the defined geographical boundaries. The review would include a survey of:

- parking spaces
- passenger loading zones
- curb ramps\cuts
- ramps
- walks
- stairs
- elevators
- doorways & doors
- public telephones,
- bus stops

- postal boxes
- signs
- lighting
- public washrooms
- vending machines, bank machines, ticket dispensers
- assisted listening devices
- TDD telephones
- emergency alarm systems
- traffic signals

While community services would not be formally reviewed, any comments or complaints received during the process would be recorded in the final report, as a step toward raising awareness of the needs of persons with disabilities.

The Advisory Committee would conduct the review with the assistance of City staff and members of the Metrotown community.

# 3.0 EVALUATION GUIDELINES

To ensure that elements within the accessibility review are assessed in a consistent and accurate manner, staff would work with the Advisory Committee to develop appropriate evaluation guidelines and a checklist for the elements under review.

The design standards would be based on information collected from the B.C. Building Code, Barrier Free Design Guidelines of the Canadian Standards Association and other Canadian and American reference documents, in addition to personal observations of persons with disabilities who participate in the review process.

# 4.0 COMMUNITY INVOLVEMENT

The Advisory Committee suggested that opportunity be provided for community members to participate in the review process. To assist in defining community involvement in the review, the Advisory Committee met with citizens of the Metrotown area who expressed an interest in access issues during the Metrotown Social Planning consultation in 1991. These citizens are interested in assisting the Access Advisory Committee in conducting the accessibility survey of the Metrotown area. The following three groups have also been identified as important participants in the review process:

### General Public

It is proposed that a notice be included in Information Burnaby. The notice would provide a general overview of the accessibility review and request residents to forward their accessibility concerns to City staff. Staff would also explore the possibility of placing an article in corporate newsletters (e.g. BC Tel, BC Transit, Eaton Centre newsletters) to advise of the review process.

The advisory group for the proposed review also suggested that the notice be published in the two local newspapers. Notices and posters would also be distributed to churches, medical offices, libraries, recreation centres and other community centres and businesses in the area.

In addition, as part of the review process, the advisory group is proposing to staff the information kiosk in the pedestrian bridge between Eaton and Metrotown Centre to distribute information and solicit public comment on access issues.

# Business Owners/Operators in Metrotown

It is proposed that copy of this report, along with a letter of invitation, be sent to business owners/operators and security companies operating in the Metrotown area. The letter would advise the business community of the review and invite their involvement in the review process.

Staff would meet with interested business operators to define their involvement in the review process and their concerns regarding accessibility in the area.

### Service Providers

It is proposed that organizations providing services to persons with disabilities in Metrotown be invited to comment on accessibility concerns. Organizations to be contacted would include the Health Department, HandiDart, BC Transit, Burnaby Association for the Mentally Handicapped, Burnaby Hospital, group home operators, seniors' housing centres and other community service agencies.

It is anticipated that this broad range of community involvement in the review process will assist in developing a comprehensive inventory of accessibility barriers in Metrotown. Staff also believe that active involvement of the community in this process will assist in ensuring that practical progress can be made in addressing identified barriers in the Metrotown core.

### 5.0 ANTICIPATED RESULTS

With the completion of the accessibility review in the Metrotown area, the Advisory Committee would compile a listing of identified barriers. The listing would include:

- the identified barrier and design deficiency
- the recommended action to remove barrier
- the organization responsible for corrective action

With Council approval, this information would be distributed to the appropriate organization responsible for corrective action. This may include City Departments, individual businesses, Provincial Ministries, and Crown Corporations.

It is also anticipated that the information collected during the review could contribute to the development of an access guidebook for the Metrotown core area. Staff would examine options for production of a guidebook with the business community in the Metrotown area.

It is anticipated that a report on the results of the accessibility survey of the Metrotown core area would be ready for consideration of the Community Issues & Social Planning Committee and Council in 1994 Spring.

# 6.0 **BUDGET CONSIDERATIONS**

The majority of the costs associated with carrying out this accessibility review in the Metrotown area will be accounted for in existing budgets for City staff salaries. Additional support for the project will be provided on a volunteer basis by Burnaby citizens involved with the Access Advisory Committee.

Other costs associated with the project have not been accounted for in 1993 budget. These include the following:

These costs will be included in the 1993 Recast Budget.
