SUBJECT:

ABANDONMENT OF INACTIVE REZONING BYLAWS

PURPOSE:

To put forward a number of rezoning amendment bylaws for Council to

abandon in accordance with adopted Council policy.

RECOMMENDATION:

1. **THAT** Council authorize the bringing forward for abandonment of the outstanding Bylaws listed in this report.

REPORT

1.0 BACKGROUND INFORMATION:

1.1 In accordance with a long standing Council policy, this report is being submitted in order for Council to abandon outstanding incomplete rezoning amendment bylaws. In accordance with the policy, Planning staff wrote to the rezoning applicants (and where it is pertinent both the applicant and the current owners) where the rezoning was not being actively pursued, advising that unless progress could be demonstrated in satisfying the prerequisite conditions, the rezoning would be included in a list of rezonings to be recommended for abandonment by Council.

In addition to dealing with the abandonment of rezoning bylaws, staff have written to applicants for rezonings which are inactive and had not previously reached the Bylaw stage. Unless otherwise directed, staff will be closing the files on those rezoning applications which have been inactive and are not being pursued.

2.0 GENERAL DISCUSSION:

2.1 In response to the above noted letters, requests to keep the rezonings active were received from several applicants or owners. Where some progress has been made on the rezoning application, the rezoning has not been included

in this report.

2.2 The following is a summary of all the rezoning amendment bylaws which are recommended to be abandoned in accordance with adopted Council policy. Included are bylaws which have been superseded by other rezoning bylaws which were subsequently advanced and given readings.
