Mr. Wakabayashi provided Council with a brief overview of the proposed development which includes a 50,000 square foot cultural centre, museum, authentic Japanese Garden, seniors complex and health care facility.

Mr. Wakabayashi noted that development costs for the project are significant and with the addition of parkland acquisition charges, the cost may be too prohibitive to proceed.

The speaker is requesting that Council accept a 1.5 acre site set aside for park development and the one-half acre Japanese garden in lieu of the parkland acquisition charge. The speaker concluded by requesting the continued support of Council and staff toward the development.

Councillor Rankin entered the Council Chamber at 7:17 p.m. and took his place at the Council table.

Mr. George Oikawa, National Nikkei Heritage Society appeared before Council to provide a description of the organizations which form the National Nikkei Heritage Society and provide details of their proposed development of cultural facilities related to the Toho development project.

Mr. Oikawa reiterated Mr. Wakabayashi's concerns with respect to the effect of the parkland acquisition charge on the development and requested that Council waive this charge in lieu of the provision of the Japanese Garden and additional park site.

The City Manager submitted a report from the Acting Director Planning and Building requesting Council approve adjustments to the proposed revised draft, Edmonds Town Centre West Development Plan arising out of further continued discussions with the proposed developer of the area. Clarifications to be included in the proposed draft plan involve the cultural centre/health care facility and under unit parking for townhouses.

9. Use of Applicable Neighbourhood Parkland Acquisition Charges

The City Manager submitted a report from the Acting Director Planning and Building recommending a policy regarding the use of applicable Neighbourhood Parkland Acquisition Charges for acquisition of park area related to residential developments under the rezoning process. Currently a per unit charge is applied to any residential rezoning containing more than three units. The established charge varies with type and density, and is reduced by fifty percent for senior citizens developments.

Staff are recommending that where area plans are adopted, and associated Comprehensive Development rezonings establish plan guidelines for the area, and the related subdivisions involve the dedication or transfer to the City a park and open space lands sufficient to serve the area and with a value equivalent to the total Neighbourhood Parkland Acquisition Charges that would otherwise apply to the area, Neighbourhood Parkland Acquisition Charges are not applied to individual multi-family residential development sites within the area.

Further, staff recommend that where a rezoning for multiple family development and a related subdivision involve the dedication or transfer to the City of private lands for park purposes in accordance with an adopted Community Plan and/or the adopted Parks Acquisition Program, the Neighbourhood Parkland Acquisition Charge applicable to the development will be reduced by an amount equivalent to the value of the acquired parkland.

The City Manager recommended:

1. THAT Council adopt the policy regarding the applicability of Neighbourhood Parkland Acquisition Charges in instances where land for park purposes is acquired in conjunction with rezonings for residential developments as outlined in Section 3.0 of this report.

The City Manager submitted a report from the Acting Director Planning and Building submitting the proposed revised Edmonds Town Centre West Development Plan as the basis for requesting comments from area residents and property owners.

As a result of the phasing out and enclosing of the Burnaby South Secondary School on its current site, and the establishment of a new Burnaby South 2000 School at the selected McPherson Park location, the former Burnaby South School site on the south side of Kingsway just west of Sperling Avenue is available for redevelopment. Staff are recommending that Council afford surrounding residents and property owners an opportunity to comment on the proposed revisions to the Edmonds Town Centre West Development Plan. Public response would then be summarized in a further report to Council at approximately the end of April. A recommendation for adoption of the finalized revised development plan would be made at that time.

In addition, the groups would develop recommendations to address identified concerns. An additional consultation session would be held with a multi-ethnic group drawing from a cross-section of the ethnic specific participants.

The community consultation process would assist in establishing new communication links with and between Burnaby's ethnic communities; provide information on existing services in Burnaby to our ethnic communities and identifying required service improvements and expansion; allow for an assessment knowledge of existing services in Burnaby; improve the ability of ethnic groups to participate in the community, and develop the skills of City staff members in interacting with ethnic specific and multi-ethnic groups; and make a complementary contribution to other research in the Lower Mainland in the area of service delivery in a multicultural environment.

THEREFORE BE IT RESOLVED THAT undedicated City properties in the following parksites, involving approximately 650 acres, be considered for dedication as part of the 1993 City elections in November of this year:

1. Central Park
2. Barnet Marine Park
3. Burnaby Mountain Conservation Area
4. Capitol Hill Conservation Area
5. Burnaby Lake Regional Nature Park
6. Fraser River Foreshore Park
7. Brunette River System

FURTHER BE IT RESOLVED THAT the Parks and Recreation Commission with the assistance of the City staff more specifically define those undedicated City properties within the above parksites for inclusion within the dedication bylaw and subsequent approval by Council."

"Stalking" a Crime

Councillor Lawson introduced a Notice of Motion with respect to amendments to make "Stalking" a criminal offense.

MOVED BY COUNCILLOR LAWSON:  
SECONDED BY COUNCILLOR EVANS:

"THAT WHEREAS with increasing frequency the media are reporting tragic stories of women being stalked and often harmed and

WHEREAS there are no laws in Canada to make the act of stalking a criminal offense and

WHEREAS over half of the States in the United States have such laws and

WHEREAS only the Federal Government in Canada has the power to protect women from being stalked by making such action a criminal offense

THEREFORE BE IT RESOLVED that Council place before the Federation of Canadian Municipalities a resolution asking the Government of Canada to amend the Criminal Code to make stalking a criminal offense punishable by a jail sentence for a first offense along the lines of laws already in place in the United States of America, and along the lines of the Private Members' Bill proposed by the Burnaby New Westminster Member of Parliament and

BE IT FURTHER RESOLVED that a copy of this resolution be sent to Burnaby's Members of the Legislative Assembly and Members of Parliament."
