PURPOSE:

To seek approval for submission of a grant proposal to Multiculturalism and Citizenship Canada to help fund a proposed consultation process with selected ethnic groups in Burnaby.

RECOMMENDATION:

- 1. **THAT** Council be asked to approve the submission of a grant request to Multiculturalism and Citizenship Canada as outlined in this report.

REPORT

1.0 <u>INTRODUCTION</u>

In 1986 Council adopted a City Multicultural Policy and authorized the establishment of a Multicultural Staff Working Group to assist with implementation of the policy. The Working Group coordinates activities related to an annual work program approved by Council, and assists in the identification of additional objectives to further Burnaby's Multicultural Policy.

The Staff Working Group has identified an opportunity to submit a proposal for a grant to Multiculturalism and Citizenship Canada for a project to further objectives as related to the annual work program approved by Council.

This report outlines, for the approval of the Community Issues & Social Planning Committee & Council, a proposed grant submission to Multiculturalism and Citizenship Canada - Race Relations and Cross-Cultural Understanding Program. The proposed grant submission is for a project to undertake a community consultation process with selected ethnic groups in Burnaby.

2.0 OVERVIEW OF GRANT PROPOSAL

The Staff Working Group proposes to seek funding to hold 5 consultation sessions with representatives of specific ethnic groups in Burnaby. Through a facilitated process, each group would identify barriers for their ethnic community in obtaining community services. In addition, the groups would develop recommendations to address identified concerns. An additional consultation session would be held with a multi-ethnic group drawing from a cross-section of the ethnic specific participants. This multi-ethnic group would review the issues identified to highlight common concerns and develop recommendations that are general to all groups.

The key objective of the consultation process is to collect information on barriers to obtaining services as experienced by ethnic groups in Burnaby, and to develop specific recommendations for changes that would improve services, access and participation for members of Burnaby's ethnic communities. In addition, this community consultation process would also meet a number of other objectives including:

- Establishing new communication links with and between Burnaby's ethnic communities.
- Providing information on existing services in Burnaby to our ethnic communities, and identifying required service improvements and expansion.
- . Allowing for an assessment of the current knowledge of existing services in Burnaby.
- Improving the ability of ethnic groups to participate in the community, and developing the skills of City staff members in interacting with ethnic specific and multi ethnic groups.
- Making a complementary contribution to other research in the Lower Mainland in the area of service delivery in a multicultural environment.

The project would seek broad community involvement and active participation by other organizations to assist with the selection of community participants. The project would be coordinated by a consultant working under contract to the City. The Multicultural Staff Working Group would serve as a resource team and supervision body for the project consultant. City resources and staff assistance for the project would be provided through the Staff Working Group.

Appendix 1 <u>attached</u> provides an overview of the timelines and activities for the proposed project.

3.0 PROJECT BUDGET AND TIMELINES

The Race Relations and Cross-Cultural Understandings Program of Multiculturalism and Citizenship Canada provides for grants of up to \$15,000 for projects and activities directed towards institutional change, public education, advocacy or cross-cultural training. Staff believe that the outlined consultation process meets the broad objectives of the program.

Project applications for the program must be submitted prior to 1993 April 1. The proposed project completion is scheduled for 1994 January.

The criteria for project funding encourages substantial financial commitment to the project by the applicant. In this case, the City of Burnaby would need to demonstrate support for the project through direct funding or services and resources in-kind.

In developing the grant proposal, staff have identified City resources that could be used to assist the project through the Multicultural Staff Working Group. In particular, City resources for support of the project would include:

- advertising / tendering process for the selection of the project consultant.
- . contribution of staff time to assist the project consultant.
- supervision of project consultant and the project through the Multicultural Staff Working Group.
- contribution of meeting space and supplies for the consultation sessions.

Staff estimate this contribution at \$9,490. These costs would be absorbed through existing City budgets. A summary of the proposed budget for the project is presented in Appendix 2 attached.

With the approval of the Community Issues & Social Planning Committee & Council, staff will submit a grant proposal to Multiculturalism and Citizenship Canada as outlined in this report. We would anticipate receiving a reply from Multiculturalism and Citizenship Canada by 1993 April.

Staff will keep the Community Issues & Social Planning Committee informed of the results of the grant application and the progress of the project.
