a) Mr. David S. Mah, co-owner of 245 N. Sea Avenue appeared before Council regarding the Local Improvement Program for ornamental street lighting on Highfield Drive.

Councillor Lawson arrived at the Council Meeting at 7:09 p.m. and took her place at the Council table.

Mr. Mah reminded Council of his previous appearance before Cuoncil as a delegation to advise of the concerns of abutting residents regarding the local improvement project who felt that their view corridors would be negatively impacted by the proposed location of the street lighting. As a result of these concerns Council directed staff to investigate and report on the possibility of using a different light standard for the project and in particular include a shorter style of lamp standard. Mr. Mah indicated that his appearance before Council this evening was to indicate his support for the Engineering Department's new plans not to install a new light pole between the properties located at 245 and 241 N. Sea Avenue.

In concluding, Mr. Mah expressed his disappointment with respect to the process followed for local improvement program projects and suggested that staff conduct an internal study to determine how to improve the local improvement process to ensure that the end result reflects the wishes of the residents involved.

Arising from the discussion Councillor Corrigan was granted leave to introduce the following motion:

3. Delegation from Mr. Mah, 245 Sea Avenue, Burnaby, Regarding Local improvement Street Lighting Project on Highfield Drive

> The City Manager submitted a report from the Director Engineering responding to Council's request for a report on the possibility of utilizing a different light standard for the local improvement project on Highfield Drive, particularly that staff investigate a shorter style of lamp standard. Staff conclude that the streets of Highfield Drive and North Sea Avenue meet each other at a very acute angle thus creating a unique circumstance of intersection geometrics rather than the more conventional right angle. Given the intersections geometrics, the lighting design originally proposed for Highfield Drive would serve to contribute benefit to a future lighting project on North Sea Avenue. The property owners have not at this time requested a local improvement lighting project on North Sea Avenue. Staff, therefore, recommend that the pole designed to be placed adjacent to 241 and 245 North Sea Avenue be deleted from the Highfield Drive project. Staff further noted that any future lighting project on North Sea Avenue would require the re-introduction of a street light in the vicinity of the intersection.

The City Manager recommended:

- 1. THAT staff proceed to complete the Local Improvement Street Lighting Project on Highfield Drive by Installing three of the four lamp standards as outlined in this report.
- 2. THAT a copy of this report be sent to all affected property owners.

b) Mr. Vic Blancard, 4630 Highlawn Drive, Burnaby appeared before Council and offered his congratulations to the elected Council members. The purpose of Mr. Blancard's presentation resulted from an article which appeared in the 1993 November 02 edition of the Province newspaper regarding a citizen tax revolt in Washington State.

Mr. Blancard advised that Canadians pay the second highest taxes in the world and suggested that government should convert their energy into campaigning to make changes to reduce taxes.

In concluding, Mr. Blancard expressed concern over the fact that some properties are taxed more than others and appealed to Council to place a cap on homeowner property taxes in Burnaby.

 d) Province of B.C., Minister of Transportation and Highways,
 1993 November 18,
 Re: Pedestrian activity and traffic safety in vicinity of Lougheed Highway and Bell Avenue

A letter dated 1993 November 18 was received from the Minister of Transportation and Highways in response to Council's correspondence regarding pedestrian activity and traffic safety in the vicinity of the Lougheed Highway and Bell Avenue. The Minister states that in order to ensure the safe movement of people, they will continue to work towards the long term solution to pedestrian traffic in the vicinity of Bell Avenue and Lougheed Highway. However, in the short term, the Minister has asked her staff to pursue the option of pedestrian controlled signalization, complete with advance warning flashers in each direction of this intersection, as well as the enhancement of the walkways and lighting in and around the pedestrian underpass approximately 450 metres east of Bell Avenue.

Councillor Rankin retired from the Council Chamber at 7:52 p.m.

In response to the Minister of Transportation and Highway's invitation, Council requested staff to arrange for a meeting with Ministry officials in the beginning of the new year to work towards a coordinated transportation plan for the Bell Avenue/Lougheed Highway community.

e) Ebba Reiter, 1993 November 16, Re: Heavy traffic on side street (Mayfield) adjacent to my property at 6681 Canada Way

A letter dated 1993 November 16 was received regarding the volume of traffic on Mayfield Street adjacent to the writer's property which is located at 6681 Canada Way. The writer indicated that the heavy traffic on Mayfield Street is only compounded by an overall increase in street parking due to additional residents' cars which provide only a narrow passage, entirely suitable for resident needs but not appropriate to the volume of cars per minute in rush hours that they are now experiencing.

The writer concluded by requesting a no left turn off of Canada Way onto Mayfield Street and that ice warning signs be installed to warn the motorist of the hazardous conditions during the winter months.

Item 5, City Manager's Report No. 70, 1993 November 29 was brought forward for consideration at this time.

 Letter from Ms. Ebba Reiter, 6681 Canada Way, Burnaby, B.C., V5E 3P9 Regarding Canada Way/Mayfield Street Intersection

The City Manager submitted a report from the Director Engineering responding to correspondence from Ms. Ebba Relter, 6681 Canada Way regarding traffic safety concerns at the Mayfield/Canada Way intersection. Staff indicate their support for signing which would prohibit the left turn movements at this time. Given the proximity of Formby Street to Mayfield Street staff recommend a common approach at both intersections to avoid transfer of the problem from one intersection to another. However, staff suggest contacting the affected residents prior to requesting implementation by the Ministry of Transportation and Highways which is responsible for traffic regulation on Canada Way. If there is significant concern by residents relative to the restriction of access imposed by the turn restriction, staff will bring this matter back to Council via the Traffic and Transportation Committee.

The City Manager recommended:

- 1. THAT residents of the Mayfield and Formby Streets south/west of Canada Way be informed of the proposal to prohibit left turns at the junctions of their street and Canada Way.
- 2. THAT a copy of this report be sent to Ms. Ebba Reiter, 6681 Canada Way, Burnaby, B.C., V5E 3P9.

18. Letter from City of Vancouver, 453 W.12th Avenue, Vancouver, B.C. V5Y 1V4Regarding Boundary Road Transmission Line

The City Manager submitted a report from the Director Planning and Building seeking Council's support for the City of Vancouver's request that the B.C. Utilities Commission undertake a public inquiry concerning the undergrounding of the Boundary Road Transmission line. Staff indicate that the costs to the City of Burnaby, if any, related to a public inquiry have not been identified and that a future report to Council will outline funding requirements for consideration should this become necessary.

A letter dated 1993 November 09 was received advising that the City of Port Moody has adopted the position of the City of Vancouver to request the Provincial Minister of Environment to designate False Creek, English Bay and Vancouver Harbour (First Narrows to Second Narrows) under the proposed Pleasure Craft Sewage Pollution Prevention Regulations and to encourage the Federal Minister of Transport to enact regulations to control sewage discharges from commercial marine vessels other than pleasure craft.

A staff notation appended to this item of correspondence advises that on 1993 October 15 Council received a report from the City of Vancouver that requests Burnaby Council support for the following two recommendations:

- "1. THAT the Provincial Minister of Environment be requested to designate Faise Creek, English Bay and Vancouver Harbour (First Narrows to Second Narrows) under the proposed Pleasure Craft Sewage Pollution Prevention Regulations (PCSPPR); and
- 2. THAT Council encourage the Federal Minister of Transport to enact regulations to control sewage discharges from commercial marine vessels other than pleasure craft."

Council on this occasion referred the matter of extending the boundaries east of the Second Narrows to staff for a report. It is expected that this report will be available for Council's consideration on 1993 December 20.

Board aimed at improved integration of group homes in the region and invites Council to forward any comments it may have on the recommendations directly to the Province.

The Minister Indicated that he has requested his staff to share the proposed policy with the members of the Inter-Ministerial Coordinating Committee on Special Needs Housing for both feedback and suggestions. The mandate of this Committee is to provide effective coordination between housing programs and support programs' funding to communities for individuals with special needs. This Committee is also working on ensuring that integration of individuals with special needs is accomplished in a way that is responsive and sensitive to both the individual and the community.

F.C.M., President, 1993 November 09, Re: Residential Rehabilitation Assistance Program (RRAP)

A letter dated 1993 November 09 was received in response to Council's correspondence regarding the Federal government's cancellation of the Residential Rehabilitation Assistance Program. The writer indicates that the F.C.M. shares the concerns of Burnaby over the disasterous housing cuts contained in the April 1993 budget and has used numerous avenues, including the Canadian Housing Coalition, to oppose the dismantlement of RRAP and other federal social housing programs. The writer enclosed, for Council's information, the FCM's election report card which summarizes the respective party positions and FCM's response on this matter.

 Province of B.C., Minister of Transportation and Highways, 1993 November 12,
 Re: Pedestrian signal at Intersection of Kingsway and Arcola Street

A letter dated 1993 November 12 was received from the Minister of Transportation and Highways in response to Council's request to retain the pedestrian signal at the intersection of Kingsway and Arcola Street. Ministry staff have investigated traffic operations at the intersection and counted motor vehicle and pedestrian traffic volumes. The Minister advised that these counts and observations indicated that the pedestrian volumes at this intersection were too low to warrant the signalization requested by Council. The Minister further advised that there was an agreement on the Ministry's part to install a pedestrian signal at Kingsway and MacPherson Avenue and understood that the City of Burnaby would be willing to give up the existing signal at Arcola Street if it became unwarranted due to the relocation of the Burnaby High School. In light of the results of the traffic and pedestrian count, the Ministry plans to remove the existing pedestrian signal and relocate it to the intersection of Kingsway and MacPherson Avenue.

 Letter from the Province of B.C., Ministry of Transportation and Highways, Parliament Buildings, Victoria Regarding Kingsway/Arcola Pedestrian Signal

The City Manager submitted a report from the Director Engineering addressing concerns regarding the removal of the pedestrian signal at Kingsway and Arcola Street as proposed in a letter from the Minister of Transportation and Highways.

Staff advised that the City has agreed to cost sharing a new installation at MacPherson Avenue. It has been suggested to Ministry staff that the Arcola Street signal be retained at present and that the Arcola Street crossing be further monitored especially given the recent pedestrian fatallty at the location. The Arcola signal is now a sunk cost, half of which was funded by the City and little would be gained in moving precipitously on its removal. Staff have suggested to the Ministry staff that they review warrants at Arcola Street again next year.

The City Manager recommended:

- 1. THAT the existing pedestrian signal at Kingsway and Arcola Street be retained subject to further monitoring and review.
- 2. THAT a copy of this report be mailed to the Honourable Jackie Pement, Minister of Transportation and Highways.

A letter dated 1993 November 05 was received addressing B.C. Transit's plans for the North Burnaby transit service. The writer requested Council advise B.C. Transit that it accepts their changes to the Hastings Express as soon as possible but that Council demand that the rest of the North Burnaby transit service proposal be put on hold until Council is satisfied that the needs of Burnaby citizens are met.

A staff notation appended to this item of correspondence advises that prior to Council's approval of the North Burnaby Transit Service Proposals in 1993 April, Independent Canadian Transit Union representatives, including the correspondent appeared before the the Traffic and Transportation Committee on two occasions to present their views. It is suggested that Mr. Mullan be invited as a delegation to the next meeting of this Committee on 1993 December 09.

- B.C. Transit is currently undertaking a survey of the views of Burnaby residents on the North Burnaby Transit Service Proposals and a report on the survey results will be submitted to the Committee and Council for consideration in the near future.
- q) Peter Hanson, 1993 November 10, Re: Concerns regarding local crime and telephone response on R.C.M.P.'s non-emergency calls

A letter dated 1993 November 10 was received expressing concerns regarding local crime and the telephone response time on the R.C.M.P.'s non-emergency calls. The writer suggested that the non-emergency number in the Burnaby Detachment is not getting the attention it should by not being answered and being on hold for long periods of time.

The locational guidelines serve to further limit potential negative impacts from such establishments on vulnerable adjacent land uses.

Applied strictly, staff indicate that the guidelines would restrict locational opportunities for pool/billiard halls and amusement arcades with a few exceptions, to enclosed shopping mails. However, applied as they are intended — with discretion and flexibility — the guidelines will help create a more appropriate balance between the establishment of pool/billiard and arcade businesses and the need to protect adjacent residential and other sensitive uses.

The City Manager recommended:

1. THAT Council approve the revised locational guidelines for assessing rezoning applications for pool/billiard halls and amusement arcades, presented in Appendix 1, attached.

In concluding, notwithstanding the Community Plan Four designation for possible RM5 type development for a seven lot consolidation (site B) the development of proposed low-rise apartment has merit considering the prevailing RM3 District zoning, the proposed four lot consolidation, and adjacent existing low-rise apartment development. Therefore, unless otherwise directed by Council staff would be prepared to release demolition permits for existing buildings and a preliminary plan approval for a low-rise apartment for the subject site in accordance with the prevailing RM3 District zoning.

Councillor Corrigan returned to the Council Chamber at 9:11 p.m. and took his place at the Council table.

Councillor Nikolai

Councillor Nikoiai advised that he had recently heard that the Premier of the Province intended to rename the "Queen of Burnaby".

Councillor Nikolai was given leave by Council to introduce the following motion:

MOVED BY COUNCILLOR NIKOLAI: SECONDED BY COUNCILLOR LAWSON:

"THAT the Premier of the Province of British Columbia be requested to include the name of 'Burnaby' in the renaming of the 'Queen of Burnaby' vessel."

CARRIED UNANIMOUSLY

Councillor Nikolai then took the opportunity to reflect on his past 12 years as a member of Burnaby City Council. Councillor Nikolai briefly touched on the many accomplishments of the Committees on which he served during his tenure and recognized the privilege, honour and responsibility bestowed upon him in serving the community.
