2. Ms. Barb Edwards, Agriculture Canada, appeared before Council to provide an update on the status of the application to spray for eradication of the European Gypsy Moths. The speaker advised that Agriculture Canada expects to receive their spray permit on January 05 for a two year period. There is a 30 day appeal period and following an Appeal Board review the spray program, if approved, will commence.

1993 January 04

Ms. Edwards then provided a response to various questions submitted by Dr. Arlene King, Burnaby Medical Health Officer on behalf of Council. The policy used by Agriculture Canada to initiate an eradication program depends on individual cases. If it is believed a reproducing population exists, then an eradication program is implemented. Agriculture Canada has been conducting eradication programs since 1979, using both ground and air spray programs. It has been determined that the aerial spray program is most effective and economical, but consideration is being given to a ground spray program as well as the use of a massive trapping program. The speaker advised that Btk will not have any impact on the wildlife or aquatic wildlife in the Burnaby Lake area. Some lepidopterans will be eliminated by Btk but it will not have a negative impact on bird life.

The speaker then commented on a staff report regarding a meeting with Washington State officials to discuss Asian Gypsy Moths. Ms. Edwards advised that minutes of this meeting will be made available to Council when they are published.

The speaker concluded by advising that Agriculture Canada plans to conduct an aerial spraying program within 40 hectares around the RV site where the original European Gypsy Moths were trapped, or may consider a ground spray program of the RV site and adjacent bush area depending upon the budget allocation for the spray program.

Council requested that Agriculture Canada provide copies of all research information currently available on the European Gypsy Moths.

Councillor Rankin read a communique from the Federation of Canadian Municipalities dated 1992 December 14 advising that the Federal Government has imposed an immediate freeze on grants-in-lieu for federally owned properties across Canada.


